SUPPLY AND FIT CANOPIES FOR STANDBY GENERATORS

1. OBJECTIVE

The main objective of this SOW is For contractors to supply and construct canopies for 4 standby generators around the port . The generators are in four different areas.

2. SCOPE OF WORK

Contractor to conduct the following:

- Supply and fit enclosures for 3 standby generators
- The housing should be 2500mm x2700mm x 2300mm (W x L x H)
- Materials to be made of fibre glass
- Enclosure to be lockable
- Provision to be made for exhaust or chimney
- Side ventilation to be made for cooling processes
- Allowance for free movement inside during inspections and testing


Please note service provider is required to meet a minimum of 70% failure to do so will deem the bidder non-responsive.
