- 2.2 Respondents failing to attend the compulsory RFQ briefing will be disqualified

- 3.3 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

5 Employment Equity Act

6 Changes to Quotations

Changes by the Respondent to its submission will not be considered after the closing date and time.

7 Binding Offer

Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

8 Disclaimers

8.1 Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that Transnet reserves the right to:

- modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
- reject any Quotation which does not conform to instructions and specifications which are detailed herein;
- disqualify Quotations submitted after the stated submission deadline;
- not necessarily accept the lowest priced Quotation or an alternative bid;
- place an order in connection with this Quotation at any time after the RFQ's closing date;
- award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;
- split the award of the order/s between more than one Supplier/Service Provider should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- cancel the quotation process;
- validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- request audited financial statements or other documentation for the purposes of a due diligence exercise;
- not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provides for it;

10 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

11 Security clearance

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

12 National Treasury's Central Supplier Database

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Transnet is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. Business may not be awarded to a respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD. For this purpose, the attached SBD 1 Form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.

13 Tax Compliance

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

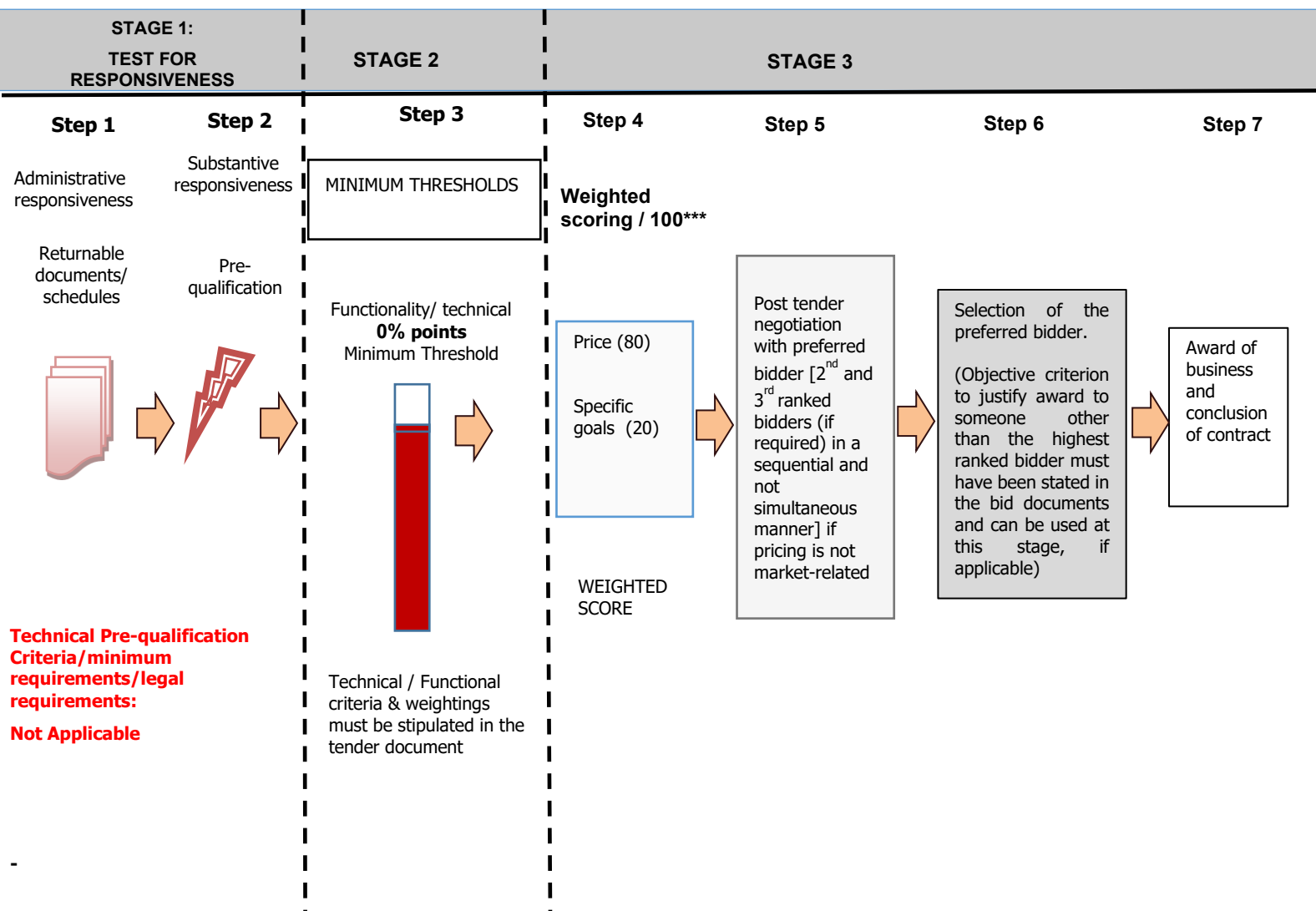

1.2 STEP FIVE: Post Tender Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
 - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
 - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

1.3 STEP SIX: Objective Criteria (if applicable)

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- Skills Transfer and Capacity Building for Transnet;
- Impact on Transnet's Return On Investment;
- Rotation of Suppliers to promote opportunities for other suppliers, by overlooking a supplier that has been awarded business repeatedly overtime in order to benefit other suppliers in the market;
- the tenderer:
 - is not under restrictions, or has principals who are under restrictions, preventing participating in the employer's procurement,
 - is not undergoing a process of being restricted by Transnet or other state institution that Transnet may be aware of,
 - can, as necessary and in relation to the proposed contract, demonstrate that he or she possesses the professional and technical qualifications, professional and technical competence, financial resources, equipment and other physical facilities, managerial capability, reliability, experience and reputation, expertise and the personnel, to perform the contract,
 - has the legal capacity to enter into the contract
 - is not insolvent, in receivership, under Business Rescue as provided for in chapter 6 of the Companies Act, 2008, bankrupt or being wound up, has his affairs administered by a court or a judicial officer, has suspended his business activities, or is subject to legal proceedings in respect of any of the foregoing,
 - complies with the legal requirements, if any, stated in the tender data and
 - is able, in the option of the employer to perform the contract free of conflicts of interest.

- all Risks identified during a risk assessment exercise/probity check (which may be conducted by an authorised third party) that would be done to assess all risks, including but not limited to:
- the financial stability of the bidder based on key ratio analysis, which would include, but not be limited to Efficiency, Profitability, Financial Risk, Liquidity, Acid Test, and Solvency;
- a due diligence to assess functional capability and capacity. This could include a site visit;
- A commercial relationship with a Domestic Prominent Influential Person (DPIP) or Foreign Prominent Public Official (FPPO) or an entity of which such person or official is the beneficial owner; and
- Reputational and Brand risks

1.4 STEP SEVEN: Award of business and conclusion of contract

- Immediately after approval to award the contract has been received, the successful or preferred bidder(s) will be informed of the acceptance of his/their Quotation by way of a Letter of Award. Thereafter the final contract will be concluded with the successful Respondent(s).
- Otherwise, a final contract will be concluded and entered into with the successful Bidder at the acceptance of a letter of award by the Respondent.

2 Validity Period

Transnet requires a validity period of 90 [Ninety] Business Days from the closing date of this RFQ, excluding the first day and including the last day.

Bidders are to note that they may be requested to extend the validity period of their bid, on the same terms and conditions, if the internal evaluation process has not been finalised within the validity period. However, once the adjudication body has approved the process and award of the business to the successful bidder(s), the validity of the successful bidder(s)' bid will be deemed to remain valid until a final contract has been concluded.

3 Disclosure of contract information

Johannesburg Stock Exchange Debt Listing Requirements

Transnet may also be required to disclose information relating to the subsequent contract i.e. the name of the company, goods/services provided by the company, the value and duration of the contract, etc. in compliance with the Johannesburg Stock Exchange (JSE) Debt Listing Requirements.

ANNEXURE A

SCOPE OF WORK

1. OVERVIEW

The works that the contractor is to perform pertains to the **structural maintenance, corrosion removal and painting** of two (2) **Reach Stackers** of the **Liebherr** and **Ferrari** make located at Transnet Port Terminals, Pier 2 Container Terminal in the port of Durban. The purpose of the maintenance intervention is to **preserve the asset and structurally maintain this port handling equipment**.

The work to be executed on these Reach stackers is concentrated mainly on and around the spreader channels, structure, extension boom, twist locks twist locks mechanism, cabin arrangement (interior, exterior, roof and guards), handrails, access staircases, counter balance weight, guard plates, side mirror mounting brackets, Air filter posts, cabin railing

The **Contractor** provides resources (including Skills, Materials, Tools, Equipment and Labour) as required to perform the works.

2. EMPLOYER'S OBJECTIVES

The Employer's objectives for this works is to ensure that the **structural integrity of the Reach stackers remain intact**.

The works the Contractor is to perform is expanded in the next sub heading and needs to be planned, integrated, and executed as a whole, employing quality system in the processes.

The works presented is applicable to one Liebherr Reach stacker number 05, unless otherwise stated elsewhere in this document.

3. SCOPE OF WORK:

- 3.1 Any cracks/defective welds found, are to be treated ie. **Sand blasted apply anti corrosion primer and repaint**. NDT reports that depict a "failed" result is to be repaired and subjected to re-testing until a "pass/satisfactory" result is obtained. A welding procedure specifically for the repairs of cracks is to be provided by the Contractor to the employer representative's acceptance. **All NDT tests (ie. Crack test) are to be submitted to the employer.**
- 3.2 Welding is to be performed by a coded / certificated welder.
- 3.3 Thickness testing to be conducted on gussets and tube sections where excessive corrosion is encountered. Gussets to be replaced where the thickness



has deteriorated to below 70% of the original parent metal thickness, or where cracks have been detected on the gusset.

- 3.4** Corrosion protection to be conducted on corroded areas along the whole structure and miscellaneous areas surrounding these, which includes spreader, extension boom, lifting hooks, cabin arrangement (interior, exterior, roof and guards), cabin railings, handrails, access staircases, platforms, balance weight, guard plates, side mirror mounting brackets, all hinges, mounting pins, hydraulic cylinder barrels.
- 3.5** Before the application of paint, the areas to be painted shall be cleaned of all oil, grease, salt and contaminants by the use of a high-pressure steam cleaner, or by using a high-pressure washer (minimum of 250 bar) in conjunction with a suitable water based biodegradable degreaser and thereafter left to dry.
- 3.6** Where required, the bulk of the oil and grease on the areas to be prepared and painted will have to be removed by scraping and solvent cleaning prior to high pressure cleaning.
- 3.7** Corroded areas shall be mechanically prepared to bare bright metal (ST-3, or greater) to ensure that all corrosion has been removed. The surrounding areas of localised corrosion are to be further prepared by feathering to ensure paint blending. All prepared areas are to be immediately painted with a suitable primer to prevent the area from oxidising.
- 3.8** Surface preparation and painting to be done in accordance with TPT specification EEAM-Q-008 rev 17. Should a bidder wish to offer coating system other than those specified, as an alternative, the bidder shall submit full technical details and a list comparing all appropriate details of the alternatives proposed, with the original specified.
- 3.9** Painted areas (top coat) to be painted to the existing paint colours for that area. Colour codes as per below

- 3.10** Paint thickness is to be at least 250 microns on newly applied paint after the surface has been prepared. All painted areas are to form rectangular sections and overlap on the existing painted structure.
- 3.11** Due to the site conditions and restrictions, mechanical preparation of the corroded surface to bare metal is preferred. However, if a contractor is aware of another competitive method with similar benefits, it can be presented as an alternative method to corrosion removal and painting.
- 3.12** **A three (3) year warranty** is required on the corrosion protection and paint system applied by the bidder.
- 3.13** It is the responsibility of the bidder to ensure that the paint system proposed is compatible with the existing paint system on the Reach stackers. All top coating of paint is to match the existing paint colour.
- 3.14** All corroded handrails are to be repaired . Corroded sections are to be cut off and new sections are to be welded in place. Hand railing consists of 50mm x 4 mm equal angle iron stanchions, 32 mm NB diameter tubing handrail, and 19 mm round bar knee rail. New sections are to be hot galvanized prior to installation, or manufactured from hot dip galvanized sections. Petrolatum primer corrosion prevention spray coatings are to be applied on the inside of repaired handrails.

- 3.15 Remove and replace damaged checker plates in walking area of the access and cabin, the installed checker plates must be of the same material, dimensions and type as the removed plates. The new checker plates must be coated with non-slip coating.
- 3.16 Remove rust, galvanize Handrails and other moveable items (side mirror arms), repaint as per TPT color code specifications.
- 3.17 Whole Machine to be sand blasted, apply anti corrosion and repaint.
- 3.18 Apply primer as per TPT paint specification on all items that will be painted
- 3.19 Spreader and T-Piece to be sandblasted, remove rust and repaint (Remove Cracks if any).
- 3.20 Before and After Completion, a functional test is to be performed with a representative from TPT.

4. **Methods for the Works**

The Contractor needs to submit Method Statements indicating their understanding of the works associated with, as a minimum:

- corrosion protection.
- welding; and
- Non-destructive testing.

ADDITIONAL WORK

- 4.1 **Fabrication work to be conducted** – Counterweight has a broken towing mechanism that needs to be fabricated and then welded to the machine.

5. OTHER REQUIREMENTS:

- 5.1 Only suppliers that can demonstrate sufficient recent experience in refurbishment of structural works and also have the necessary equipment to do the complete refurbishment and test, shall be considered.
- 5.2 The supplier must supply sufficient information and references with their response to enable Transnet Port Terminals to determine their level of experience.
- 5.3 Reference lists shall include addresses as well as contact persons who may be visited for inspection of the equipment during the adjudication period.
- 5.4 Transnet Port Terminals will not consider any supplier's offer who, in the sole opinion of Transnet Port Terminals, does not have adequate experience and/or adequate equipment to ensure quality of the repair work.
- 5.5 A warranty period of at least 36 months is required for the workmanship and all replaced components.
- 5.6 The Contractor makes an adequate and stable project team available for the duration of the contract. The Contractor to minimise replacement of individual project team members in order to ensure continuity.
- 5.7 In order to successfully execute the works, the Contractor ensures suitably qualified and experienced teams in the scope of structural, welding and corrosion protection.
