1 BACKGROUND

Transnet Port Terminals is a division of Transnet SOC Limited whose core business is to provide cargo handling services to a wide spectrum of customers, including shipping lines, freight forwarders, and cargo owners.

Port Elizabeth Multi-Purpose Terminal (PEMPT's) core business is to export dry bulk cargo manganese ore. This is accomplished with terminal infrastructure such as rail wagon tippler, feeders, conveyor belts, storage facilities and ship-loaders and a network of machine mobile equipment such as excavators and bulldozers. The larger network of conveyors is connected via chute and diverter chutes which allow for easy conveying of bulk material to the different conveyor lines. To ensure health and safety of TPT employees, the Technical Department aims to hire mobile toilets as detailed in this Scope of Work.

2 OBJECTIVE

It is the primary duty of TPT under the section 43 of OHS Act no. 85 of 1993, facilities regulations to ensure, so far as predictable, that workers are not exposed to health and safety risks arising from the business. The mandate of this scope of work is for the business to seek provisions of mobile toilets meeting all business requirements and compliant with all work, health and safety regulations. The detailed scope of work describes all business requirements.

3 SCOPE OF WORK

3.1 This scope is for the hiring of mobile toilets for a period of ten (10) days to Transnet Port Terminals Port Elizabeth Bulk Terminal.

3.2 The scope of work requires the supplier to:

- 3.2.1 Design as per TPT requirements and manufacture to design requirements, install, and commission the mobile toilet facilities at Port Elizabeth Terminal.
- 3.2.2 Transport the mobile toilets to and from TPT site.
- 3.2.3 Maintain cleanliness and sanitation of the facilities while they are on TPT premises.
- 3.2.4 Provide all the required plumbing and electrical network.
- 3.3 The supplier shall be responsible for the pipe and connections required from the mobile toilet to a water supply.
- 3.4 The mobile toilets shall have flush toilets.
- 3.5 All the mobile toilets shall be cleaned and sanitized daily. A daily register must be kept.
- 3.6 All the mobile toilets shall be plug and play i.e. no further modifications and adjustments are to be made on site, they shall be already fitted with the required requirements.
- 3.7 The mobile toilet requirement by TPT is:

- 4.1 Water.
- 4.2 Electricity.

5 SITE INFORMATION

- 5.1 The site is at the Bulk plant in the Port Elizabeth Multipurpose Terminal. Access will be from the existing public and maintenance road networks. Access to the Port will be subject to the TNPA and TPT security requirements and regulation.
