

- c) As per page 3 of 16 in Part 1 what is the Procurement Reference number to be used when extracting the required information on CSD
  - Log on to the CSD website on <a href="http://secure.csd.gov.za/">http://secure.csd.gov.za/</a>.
  - Click on Search and select Subcontractor Search; and
  - Enter the Procurement reference number (.....), and
  - Click on "Run Search".
- d) I have registered, and as per the tender document, once logged in, there should be an option "Log an intent", but there is no such option on the screen I have even clicked on other options to "toggle" as advised.
  - · Click on "SIGN IN/REGISTER" to sign in if already registered;
  - Toggle (click to switch) the "Log an Intent" button to submit a bid;

 Valid B-BBEE verification certificate accredited by SANAS or Sworn Affidavit and a B-BBEE certificate issued by the Companies and Intellectual Property Commission (CIPC) of each of the proposed sub-contractor(s).

## NOTE TO TENDERERS: FAILURE TO PROVIDE THE ABOVE DOCUMENT WILL RESULT IN THE PROPOSED SUBCONTRACTOR'S PERCENTAGE BEING DISCOUNTED TO ZERO.

Transnet reserves the right to request additional information of the proposed sub-contractor(s) should it be deemed necessary to verify the compliance to the black ownership percentage or sub-contractor(s) entity size. These may include but not limited to;

Tenderers are required to meet the pre-qualification criteria for preferential procurement in terms of the Preferential Procurement Regulations 2017.

Only respondents falling within the following categories may respond to this tender:

i. EMEs or QSEs.

Complete, sign and submit Returnable Schedule T2.2-1a.

Failure to meet the pre-qualification criteria stipulated above will be regarded as an unacceptable tender.

Valid B-BBEE certificates or Sworn Affidavits, company registration documents, Identity Document copies of the directors of the company and CSD report must be submitted together with the tender.

- **d)** Bidders need to make sure that they provide the company registration number and CSD number when registering their details on eTenders. This happens because there is some outstanding information missing.
- e) The contractors are not allowed change the format of the BOQ

  Because we will not know if the BOQ is tempered with, therefore the wont be time to re –check over
  50 pages BOQ again if the descriptions and quantities have not been changed.

  The contract must submit a priced BOQ on the format we gave them.

That will open a gap of pricing errors and disputes during the contract.

- **f)** The requirement for subcontracting is as follows:
- Subcontracting agreement between two parties
- B-BBEE certificate or affidavit for the subcontractor and
- CSD report for the subcontractor
- g) Only B-BBEE status level of 1-4 and subcontracting to designated Groups. A tenderer to subcontract a minimum of 30% to the designated groups.

Under T2.2-05 "Compliance to eligibility"- you ask for compliance to the Eligibility Criteria for Fencing – please advise us on how to respond to this section as there is no Fencing measured in the BOQ? Do we include in our total amount, please verify.

**Response 29:** An option B BOQ does not have a Contingency page, it is a re-measurement contract, the Bill of Quantity is only a pricing document, item 2.2.3 on pricing instruction says "Prices and rates stated in each item in the BOQ shall be treated as fully inclusive all works, risks, liabilities, obligations, overheads, profit and everything necessary as incurred or required by the contractor in carrying out or providing that item" If it happens during the contract that there is a need for an additional work that was not allowed for, a Compensation Event will be raised by the contractor as per NEC.

**Question 30:** Please advise if the below Tender is missing the following page of the BOQ, Summery page 59 of 59Tender TPT/2021/12/2/RFP BOQ

If so please could you kindly assist by providing the correct page accordingly

**Response 30:** The totals on the priced BOQ must be Excluding VAT, the contractor will then get a chance to include VAT on the tender document under "Form of Offer and acceptance" where you will transfer the total amount on the BOQ and add VAT. **Response 34:** According to the Standard System under Carpentry and Joinery – sawn and wrought timber is measured separately stating the finished size, and shall be given in linear metres

In this case the finished size of timber is 2440 x 1220 as stated on  $\ensuremath{\mathsf{BOQ}}$ 

The area to be covered is  $8.5 \times 5.1 = 43 \text{ m}$ 

NB:

The only thing that I notice is incorrect is the quantity, the Quantity is supposed to be 34 meters instead of 12

That will give you a number of (15 plywood's) of that size. **Bidder please note that Addendum 4 issued on 7 February has the rectified quantities and bidders are to use Addendum 4 for their submission**.
