**1. PURPOSE OF ADDENDUM**

1.1 To inform Bidders of:

- **Amendment made to "SBD1 FORM** i.e. – cover page, page 3 and 7 of the RFP. Closing date amended to 07 October 2025 due to the initial closing date falling on a Public Holiday (24 September 2025)
- Changes to the Specific Goals
- RFP Clarification date extension
- Closing date extension
- Inform bidders who wish to see the facility that site visits are permitted every working day (Mon-Fri) between 8:00 to 15:30, except public holidays and weekends. **2. BACKGROUND**

2.1 The RFP was published on Transnet tender website and on temporary NT eTender portal on 27 August 2025. A non-compulsory pre-proposal RFP briefing was conducted on MS Teams on the 09 September 2025, at 11H00 AM for a period of ± 2 hours. The tender was erroneously published to close on the 24<sup>th</sup> of September which happens to be a Public Holiday. Tenders usually close on working days to enable smooth closure. Therefore, it is for this reason that the tender’s closing date be extended to 07 October 2025.

2.2 The tender also erroneously had incorrect Specific Goals definitions, namely:

- Entities that are +50% Black Women Owned
  - Entities that are +50% Black youth owned.
- Now changed to
- Entities that are at least 30% Black Women Owned
  - Entities that are at least 50% Black youth Owned
