Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

The Transnet e-Tender Submission Portal can be accessed as follows:

- a) Log on to the Transnet eTenders management platform website/Portal using Google Chrome: transnetetenders.azurewebsites.net;
- b) Click on "ADVERTISED TENDERS" to view advertised tenders;
- c) Click on "SIGN IN/REGISTER to register new bidder information and ensure that all mandatory information is completed OR to sign in if already registered;
- d) Toggle (click to switch) the "Log an Intent" button to submit a bid;
- e) Respondents are to submit bid documents by uploading them onto the Transnet system against each tender selected. A Bidder can upload 30mb per upload and multiple uploads are permitted.
- Bidders should ensure that electronic bid submissions are submitted at least a day before the closing date and bidders should not wait for the last hour before the deadline to submit. This is to enable them to timeously address issues which they may encounter due to internet speed, bandwidth or the size of the number of uploads being submitted. Transnet will not be held liable for any challenges experienced by bidders as a result of their own technical challenges.
- g) No late submissions will be accepted.
- h) Each company must register its own profile using its company details and use the corresponding registered profile to log an intent to bid as well as submitting any bid. Transnet will not accept a bid or will disqualify a bidder who submits a bid in the Transnet e-tender submission through another bidders'/Company's profile. In other words, each bidder must register the intent to bid and submit its bid through its own profile under the same company name that will eventually bid for the tender. No company shall submit a bid on behalf of another company regardless of the company being a subsidiary or holding company.
- In case of a Joint Venture, any of the parties/companies to the Joint Venture may use its registered profile to submit a bid on behalf of the Joint Venture.

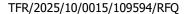

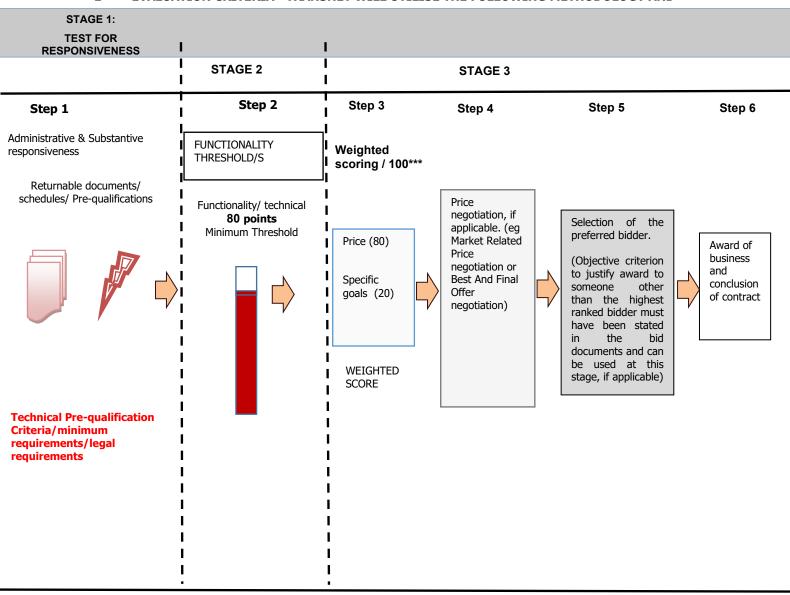

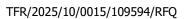

# 1.4 STEP FOUR: Price Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
  - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
  - o negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.

#### 1.5 STEP FIVE: Objective Criteria

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- Skills Transfer and Capacity Building for Transnet;
- Impact on Transnet's Return On Investment;
- Rotation of Suppliers to promote opportunities for other suppliers, by overlooking a supplier that
  has been awarded business repeatedly overtime, in the same commodity, in order to benefit other
  suppliers in the market;
- the bidder is undergoing a process of being restricted by Transnet or other state institution that Transnet may be aware of,
- the bidder is insolvent, in receivership, under Business Rescue as provided for in chapter 6 of the Companies Act, 2008, bankrupt or being wound up, has his affairs administered by a court or a judicial officer, has suspended his business activities, or is subject to legal proceedings in respect of any of the foregoing,
- the bidder is unable, as objectively determined by Transnet, to perform the contract free of conflicts of interest.

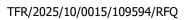

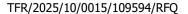

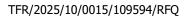

#### **6** INTRODUCTION

The Transnet Fuel Infrastructure and Solutions department oversees 47 strategically located depots across the country. These facilities are responsible for ensuring diesel availability and operational continuity for the diesel locomotive fleet.

As part of a broader infrastructure maintenance and compliance initiative, the department has identified the need for a cleaning project of the underground diesel storage tank at the Danskraal Fuel Depot, located in the Eastern Region. This intervention aims to ensure fuel system integrity, prevent environmental risks, and align with international best practices. The underground diesel storage tank at Danskraal Depot plays a critical role in supporting locomotive operations by storing bulk diesel fuel used for refuelling. Over time, underground storage tanks are susceptible to the buildup of sludge, microbial contamination, and water accumulation, which can degrade fuel quality and compromise system performance.

To address these risks, the tank will be cleaned in accordance with API 1631 – Recommended Practice for Interior Cleaning of Crude Oil and Petroleum Product Storage Tanks. This standard outlines the procedures and safety measures required for the effective cleaning of underground petroleum tanks, including confined space entry, environmental controls, and post-cleaning inspections.

#### 7 OBJECTIVES

The underground Storage Cleaning tank project described in the introductory chapter is to be performed at Danskraal Depot, which falls under the Eastern Region. The objectives of this project are listed as follows:

- Remove sludge, water, and microbial contamination from the underground diesel storage tank to restore fuel purity and storage integrity.
- > Ensure compliance with API 1631 standards, reinforcing adherence to internationally recognised fuel infrastructure maintenance practices.
- Mitigate operational risks, such as clogged filters, pump damage, or unexpected downtime caused by degraded fuel quality.
- > Support environmental protection by preventing contamination of soil and groundwater through early identification of leaks or corrosion during post-cleaning inspection.
- > Extend the lifespan of the storage tank through preventive maintenance, early detection of structural issues, and adherence to industry best practices.

#### 8 SCOPE-OF-WORKS

The scope of work for the Danskraal depot is as follows:

8.1 Tank Cleaning

#### **Preparatory Works**

- A. Positively isolate the underground storage tank from all pipes and pumps.
- B. Disconnect all electrical connections associated with the tank
- C. Perform vapor freeing/degassing or air ventilation to ensure a zero-energy state. Monitor the tank atmosphere/gas testing continuously

# Cleaning Activities

- A. Drain diesel from the tank and pipeline and transfer to a safe container (e.g Flowbin),
- B. Remove and safely dispose-off the contaminated product, sludge/residue. Submit disposal certificate as a proof.
- C. Perform tank interior cleaning of the underground storage tank in accordance with API 1631.
- D. Rinse tank walls, floor, and manway area. Collect all contaminated water and sludge for proper and safe disposal.
- E. Perform Tank interior walls sandblasting to expose the shell parent material in preparation for inspection.
- F. Inspect the tank interior for cleanliness, and confirm no flammable vapors are present through gas testing.

#### 8.2 Out-of-service Tank Inspection Activities

- A. Certified Inspector to perform visual internal (shell, roof, and floor) inspection using API 1631 Checklist. Examine for leaks, corrosion, cracks, or any damage.
- B. Ultrasonic Thickness Testing (UTT) on shell and ends
- C. Dye penetrant or vacuum box testing at weld seams
- D. Perform Magnetic Particle Inspection (MPI)
- E. MFL scanning of tank bottom and side shell (Full scan to detect corrosion areas)
- F. Manhole, tank nozzle (Entry and suction nozzles), and fitting inspection
- G. Cathodic protection system test
- H. Leak tightness test (hydrostatic or vacuum) as per API 1631 / SANS 1535

    - Transnet does not engage with non-value adding agents or representatives solely for the purpose of increasing BBBEE spend (fronting)
- 3. Transnet's relationship with suppliers requires us to clearly define requirements, exchange information and share mutual benefits.
  - Generally, Suppliers have their own business standards and regulations. Although Transnet cannot control the actions of our suppliers, we will not tolerate any illegal activities. These include, but are not limited to:
    - Misrepresentation of their product (origin of manufacture, specifications, intellectual property rights, etc);
    - Collusion;
    - Failure to disclose accurate information required during the sourcing activity (ownership, financial situation, BBBEE status, etc.);
    - Corrupt activities listed above; and
    - Harassment, intimidation or other aggressive actions towards Transnet employees.
  - Suppliers must be evaluated and approved before any materials, components, products or services are purchased from them. Rigorous due diligence is conducted and the supplier is expected to participate in an honest and straight forward manner.
  - Suppliers must record and report facts accurately, honestly and objectively. Financial records must be accurate in all material respects.
