

1.4 STEP FOUR: Post Tender Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
 - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,

2 Validity Period

1 Overview of the works

1.1 Executive Overview

Bulk terminals handle bulk commodity through the utilization of tipplers, conveyer belts and associate equipment. K71 boom conveyor plays a crucial role on K71 stockpile by discharging the cargo efficiently from both tippler routes as it is the last conveyor on chrome route selection and it consists of major mechanical and electrical components which ensure the operation of the route namely, the drive system (induction motor, hydraulic coupling and gearbox).

These components are selected in design based on the load capacity that the commodity is expected. This VSD will assist in varying and selecting the speed of the conveyor belt, the drive will also minimize the blockages caused by momentum when the route stops by controlling ramp down/ deceleration times. It has been observed that this drastic change in commodity property occurs when the cargo is wet and as a result the drive system experiences an overload. To remedy this problem the terminal has decided to upgrade the direct online system to variable speed drive type of system.
