2. TENDER SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

- a) The Transnet e-Tender Submission Portal can be accessed as follows:
 - Log on to the Transnet eTenders management platform website (https://transnetetenders.azurewebsites.net);
 - Click on "ADVERTISED TENDERS" to view advertised tenders;
 - Click on "SIGN IN/REGISTER for bidder to register their information (must fill in all mandatory information);
 - Click on "SIGN IN/REGISTER" to sign in if already registered;
 - Toggle (click to switch) the "Log an Intent" button to submit a bid;
 - Submit bid documents by uploading them into the system against each tender selected.
 - Tenderers are required to ensure that electronic bid submissions are done at least a day before the closing date to prevent issues which they may encounter due to their internet speed, bandwidth or the size of the number of uploads they are submitting. Transnet will not be held liable for any challenges experienced by bidders as a result of the technical challenges. Please do not wait for the last hour to submit. A Tenderer can upload 30mb per upload and multiple uploads are permitted.
- b) Each company must register its profile using its company details and use the corresponding registered profile to log an intent to bid as well as submitting any bid.
- c) Transnet will not accept a bid or will disqualify a bidder who submits a bid in the Transnet e-tender submission through another bidders'/Company's profile. In other words, each

- d) In case of a Joint Venture, any of the parties/companies to the Joint Venture may use its registered profile to submit a bid on behalf of the Joint Venture.
- e) The tender offers to this tender will be opened as soon as possible after the closing date and time. Any tenderer that fails to meet the stipulated eligibility criteria will be regarded as an unacceptable tender.

3. Stage Four - Functionality:

Only those tenderers who obtain the minimum qualifying score for functionality will be evaluated further in terms of price and the applicable preference point system. The minimum qualifying for score for functionality is **60** points.

The evaluation criteria for measuring functionality and the points for each criteria and, if any, each sub-criterion are as stated in C.3.11.3 below.

Each evaluation criteria will be assessed in terms of scores of 0, 20, 40, 60, 80 or 100.

4.7 Should the Tenderer find any terms or conditions stipulated in any of the relevant documents quoted in the Tender unacceptable, it should indicate which conditions are unacceptable and offer alternatives by written submission on its company letterhead, attached to its submitted Tender. 5 DISQUALIFICATION FROM TENDERING PROCESS

The imposition and duration of the exclusion will be determined by the severity of the transgression. Restricted Suppliers. Transnet reserves the right to withdraw an award, or cancel a contract concluded with a Tenderer should it be established, at any time, that a tenderer has been restricted with National Treasury by another government institution.

- 6.2 All the stipulations on Transnet's restriction process as laid down in Transnet's Supply Chain Policy and Procurement Procedures Manual (CPM included) are included herein by way of reference. Below follows a condensed summary of this restriction procedure.
- 6.3 On completion of the restriction procedure, Transnet will submit the restricted entity's details (including the identity number of the individuals and registration number of the entity) to National Treasury for placement on National Treasury's Database of Restricted Suppliers for the specified period of exclusion. National Treasury will make the final decision on whether to restrict an entity from doing business with any organ of state for a period not exceeding 10 years and place the entity concerned on the Database of Restricted Suppliers published on its official website.
- 6.4 The decision to restrict is based on one of the grounds for restriction. The standard of proof to commence the restriction process is whether a "*prima facie*" (i.e. on the face of it) case has been established.
- 6.5 Depending on the seriousness of the misconduct and the strategic importance of the Goods/Services, in addition to restricting a company/person from future business, Transnet may decide to terminate some or all existing contracts with the company/person as well.
 - 6.6 A Service Provider or Contractor to Transnet may not subcontract any portion of the contract to a blacklisted company.
 - 6.7 Grounds for blacklisting include: If any person/Enterprise which has submitted a Tender, concluded a contract, or, in the capacity of agent or subcontractor, has been associated with such Tender or contract:

- f) has made any incorrect statement in a certificate or other communication with regard to the Local Content of his Goods or his B-BBEE status and is unable to prove to the satisfaction of Transnet that:
 - (i) he made the statement in good faith honestly believing it to be correct; and

7 PREVIOUS TRANSGRESSIONS

7.1 The Tenderer/Service Provider/Contractor hereby declares that no previous transgressions resulting in a serious breach of any law, including but not limited to, corruption, fraud, theft, extortion and contraventions of the Competition Act 89 of 1998, which occurred in the last 5 (five) years with any other public sector undertaking, government department or private sector company that could justify its exclusion from its registration on the Tenderer's/Service Provider's/Contractor's database or any tendering process.

8 SANCTIONS FOR VIOLATIONS

- 8.1 Transnet shall also take all or any one of the following actions, wherever required to:
- a) Immediately exclude the Tenderer/Service Provider/Contractor from the tendering process or call off the pre-contract negotiations without giving any compensation the Tenderer/Service Provider/Contractor. However, the proceedings with the other Tenderer/ Service Provider/Contractor may continue;
- b) Immediately cancel the contract, if already awarded or signed, without giving any compensation to the Tenderer/Service Provider/Contractor;
- c) Recover all sums already paid by Transnet;
- d) Encash the advance bank guarantee and performance bond or warranty bond, if furnished by the Tenderer/Service Provider/Contractor, in order to recover the payments, already made by Transnet, along with interest;
- e) Cancel all or any other contracts with the Tenderer/Service Provider/Contractor; and
- f) Exclude the Tenderer/ Service Provider/Contractor from entering into any Tender with Transnet in future.

9 **CONFLICTS OF INTEREST**

- 9.1 A conflict of interest includes, inter alia, a situation in which:
- a) A Transnet employee has a personal financial interest in a tendering / supplying entity; and
- b) A Transnet employee has private interests or personal considerations or has an affiliation or a relationship which affects, or may affect, or may be perceived to affect his / her judgment in action in the best interest of Transnet, or could affect the employee's motivations for acting in a particular manner, or which could result in, or be perceived as favouritism or nepotism.
- 9.2 A Transnet employee uses his / her position, or privileges or information obtained while acting in the capacity as an employee for:
- a) Private gain or advancement; or
- b) The expectation of private gain, or advancement, or any other advantage accruing to the employee must be declared in a prescribed form.

- 9.3 If a Tenderer/Service Provider/Contractor has or becomes aware of a conflict of interest i.e. a family, business and / or social relationship between its owner(s)/member(s)/director(s)/partner(s)/shareholder(s) and a Transnet employee/member of Transnet's Board of Directors in respect of a Tender which will be considered for the Tender process, the Tenderer/Service Provider/ Contractor:

10 DISPUTE RESOLUTION

- 10.1 Transnet recognises that trust and good faith are pivotal to its relationship with its Tenderer / Service Provider / Contractor. When a dispute arises between Transnet and its Tenderer / Service Provider / Contractor, the parties should use their best endeavours to resolve the dispute in an amicable manner, whenever possible. Litigation in bad faith negates the principles of trust and good faith on which commercial relationships are based. Accordingly, following a blacklisting process as mentioned in paragraph 6 above, Transnet will not do business with a company that litigates against it in bad faith or is involved in any action that reflects bad faith on its part. Litigation in bad faith includes, but is not limited to the following instances:
- a) **Vexatious proceedings**: these are frivolous proceedings which have been instituted without proper grounds;
- b) **Perjury:** where a Tenderer / Service Provider / Contractor make a false statement either in giving evidence or on an affidavit;

- 2.4. Transnet reserves all the rights afforded to it by the POPIA in the processing of any of its information as contained in this Agreement and the Operator is required to comply with all prescripts as detailed in the POPIA relating to all information concerning Transnet.

1 Description of the works

1.1 Executive overview

Transnet Port Terminals is a division of Transnet SOC Limited whose core business is to provide cargo handling to a wide spectrum of customers, including shipping lines, freight forwarders and cargo owners. Operations are divided into four major business segments, namely containers, bulk, break bulk and automotive.

The Richards Bay Terminal is a material handling plant comprising of the Dry Bulk Terminal (DBT) and the Multi-Purpose Terminal (MPT). The two terminals are for importing and exporting different cargoes using mobile fleet, ship loaders, ship unloaders, stackers, stacker reclaimers and a network of conveyors.

There is a water leak from one of the gallery structures at W04, where water continuously discharges onto the ground, leading to potential erosion and uncontrolled water flow. To address this, a solution has been proposed to install a 200 mm diameter, 16 m long HDPE Class 10 pipe system to safely channel the water into a nearby reservoir tank. A custom-designed, flanged stainless-steel funnel will be positioned directly under the water outflow to capture and direct the water into the pipe, ensuring efficient and controlled drainage.

The stepway to the pumps is corroded and it is unsafe for employees to have access to the pumps to perform maintenance. The platform is also not to work on and has a high possibility of losing tools

1.2 Employer's objectives

The service provider is required to install a pipe system to redirect water leaking from W04 gallery into a reservoir tank, ensuring minimal spillage and corrosion resistance. Fabricate stepway and cad ladders

2 Detailed Scope of Work

The service provider shall perform the following tasks:

2.1 Installation of the pipe system

- 2.1.1 Install a 200 mm diameter, 16 m long HDPE Class 10 pipe to collect and direct water from the gallery into the reservoir tank.
- 2.1.2 Install the pipe in two straight sections of 7.5 m each, joined with a 45-degree elbow to create a directional bend toward the reservoir tank.
- 2.1.3 The pipe must maintain a continuous downward slope from the gallery outlet to the reservoir tank to allow gravity-driven flow.
- 2.1.4 At the inlet point (beneath the water discharge), install a custom-fabricated flanged stainless-steel funnel component to capture and guide the falling water into the HDPE pipe.
- 2.1.5 The stainless-steel funnel must be made of Grade 316L stainless steel to ensure corrosion resistance.
- 2.1.6 Funnel geometry should include a wide circular mouth (recommended ≥500 mm diameter) tapering down into a 200 mm diameter outlet.
- 2.1.7 The outlet of the funnel must terminate in a DN200 flange (PN10-rated), drilled according to SANS 1123 / ISO 7005 standards.
- 2.1.8 Use a matching HDPE flange adapter and gasket (EPDM or nitrile rubber), with stainless steel bolts and nuts (Grade A4-70 or higher) to connect the funnel to the pipe.
- 2.1.9 Secure the stainless-steel funnel to a stable structural element of the gallery using stainless steel brackets and anchors.
- 2.1.10 Ensure the funnel is aligned directly below the water flow path to capture all falling water efficiently without overspill.
- 2.1.11 Support the HDPE pipe at intervals of no more than 1.5 m using galvanized steel U-bolts or brackets to reduce vibration and wear.
- 2.1.12 At the end of the 16 m pipe run, ensure the pipe enters the reservoir tank via a 1 m vertical drop; use a suitable 90-degree elbow and flexible coupling or bell-mouth entry.
- 2.1.13 Supply all necessary material and resource to complete this project.

2.2 Fabrication of stepways and ladders

- 2.2.1 Stepway to be constructed on the 4300mm x 2700m 4 legs I beam 152mm x 152mm to be used
- 2.2.2 Two (2) back legs are 6m long, 2700m apart braced by four (4) 50mmX50mm angle iron
- 2.2.3 Brace apart into 2 pieces of 2000mm
- 2.2.4 Two (2) front legs are 4500mm high 2700mm apart and side is 4300mm apart, braced into 2 pieces apart by four (4) 50mmX50mm angle iron
- 2.2.5 Stepway is 1130mm x 3500mm are mounted at an angle of 45 and they are three of them before walkway which is 3390mm x 1100mm with handrails, stepways are connected on channel 150 x 75 x 5.7 mm two (2) per stepways
- 2.2.6 Platform and stepway only plastic gratings to be installed and stainless-steel Clip-on fasteners to be used
- 2.2.7 Eight (8) 6000mm x 1500mm platforms with handrails around must be repaired, sandblasted and painted
- 2.2.8 Stepways, walkways and on the platforms galvanized wire mash must be installed and painted
 On the side of handrails
- 2.2.9 All steel must be galvanized only clips on and bolts/nut to be stainless steel
- 2.2.10 Apply a primer suitable for harsh environments, such as epoxy or zinc-rich primers Zinc-rich primers with epoxy or polyurethane topcoat
