REPAIRS OF MOBILE DIESEL BOWSER.

MACHINE IS LOCATED IN EAST LONDON MULTI-PURPOSE TERMINAL FOR TRANSNET SOC LIMITED [REGISTRATION NO.: 1990/000900/30] **OPERATING AS TRANSNET PORT TERMINALS (HEREINAFTER REFERRED** TO AS 'TPT') AS A ONCE-OFF SERVICE.



1. OBJECTIVE

The main objective of this scope of work is to invite the contractor who will be able to perform a repair on mobile diesel bowser. Verify that the bowser is safe for use and complies with relevant regulations.

2. SCOPE OF WORK

- Fault find and conduct necessary repairs on the diesel bowser
- Check pump and nozzle operations
- Verify and replace any damaged or faded labels, including hazard warning signs.
- Inspect the pump system for proper operation. Perform necessary repairs or replacement of seals, gaskets, or other components as needed to ensure leakfree and efficient operation.
- Check and calibrate the meter reading for accurate volume measurement. Ensure compliance with relevant metering standards.
- Replace fire extinguisher mounted on the bowser.
- Verify functionality of rear lights and other safety features.
- Ensure the bowser complies with local regulations regarding mobile hazardous material transport.
- Contractor to supply all materials and spares required.
- Touch-up painting of the bowser tank and associated components to protect against corrosion.
- The contractor will take the machine and conduct repairs to his or her workshop
- On completion the machine must be brought back for testing and commissionin
 - Bidder to submit quarantee on workmanship not less than six months
