- c) Click on "SIGN IN/REGISTER to register new bidder information and ensure that all mandatory information is completed OR to sign in if already registered;
- d) Toggle (click to switch) the "Log an Intent" button to submit a bid;
- e) Respondents are to submit bid documents by uploading them onto the Transnet system against each tender selected. A Bidder can upload 30mb per upload and multiple uploads are permitted.
- f) Bidders should ensure that electronic bid submissions are submitted at least a day before the closing date and bidders should not wait for the last hour before the deadline to submit. This is to enable them to timeously address issues which they may encounter due to internet speed, bandwidth or the size of the number of uploads being submitted. Transnet will not be held liable for any challenges experienced by bidders as a result of their own technical challenges.
- g) No late submissions will be accepted.
- h) Each company must register its own profile using its company details and use the corresponding registered profile to log an intent to bid as well as submitting any bid. Transnet will not accept a bid or will disqualify a bidder who submits a bid in the Transnet e-tender submission through another bidders'/Company's profile. BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS

Transnet Rail Infrastructure Manager (TRIM), a division of Transnet SOC Ltd, operating within a dynamic and safety-critical environment, requires a reliable and compliant supply pipeline for civil-construction consumables used in culvert wall construction and rehabilitation activities at Koedoespoort. The intent of this RFQ is to secure a supplier capable of delivering consistent quality, assured continuity of supply, and responsive lead-time performance over a two-year horizon.

This requirement is a strategic lever to ensure infrastructure resilience, minimise operational downtime, and create predictable cost structures across the lifecycle of TRIM's culvert-related maintenance programme.

1 Purpose of the RFQ

The purpose of this RFQ is to appoint competent supplier(s) to supply and deliver culvert wall material on an as-and-when required basis for a period of twenty-four (24) months to Koedoespoort Depot.

The successful supplier will be required to meet technical standards, adhere to predictable response times, maintain product quality consistency, and ensure alignment with Transnet's governance, safety, and operational delivery requirements.

2 Scope of Work

The Respondent is required to supply and deliver the items in the pricing schedule (Section 7) strictly according to the technical specification below. The requirement includes:

- Delivery of materials on demand, aligned to confirmed purchase orders.
- Provision of materials that are new, unused, compliant with South African standards, and free of defects.
- Packaging and handling that ensures product integrity during transit and offloading.
- Clear traceability of batches, manufacturing standards, and product certification where applicable.
- On-time delivery to Koedoespoort, aligned to operational constraints and notified delivery windows.

This scope represents an enabling function—supporting continued maintenance of culvert walls, shuttering structures, and reinforcement frameworks deployed by TRIM personnel.



1.3 STEP THREE: Price Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
 - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
 - o negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

1.4 STEP FOUR: Award of business and conclusion of contract

- Immediately after approval to award the contract has been received, the successful or preferred bidder(s) will be informed of the acceptance of his/their Quotation by way of a Letter of Award. Thereafter the final contract will be concluded with the successful Respondent(s), where applicable.
- Alternatively, the acceptance of a letter of award by the Successful Respondent will constitute the final contract read together with their RFQ response and the Standard Terms and Conditions. This will be stated in the letter of award.

2 Validity Period

Transnet requires a validity period of 180 [One hundred and eighty] Business Days (**10 June 2026**) from the closing date of this RFQ, excluding the first day and including the last day.

Bidders are to note that they may be requested to extend the validity period of their bid, on the same terms and conditions, if the internal evaluation process has not been finalised within the validity period. However, once the adjudication body has approved the process and award of the business to the successful bidder(s), the validity of the successful bidder(s)' bid will be deemed to remain valid until a final contract has been concluded.
