#### 2 PROPOSAL SUBMISSION

Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

- a) The Transnet e-Tender Submission Portal can be accessed as follows:
  - a) Log on to the Transnet eTenders management platform website/ Portal (transnetetenders.azurewebsites.net)
  - b) Click on "ADVERTISED TENDERS" to view advertised tenders;
  - c) Click on "SIGN IN/REGISTER –to register new bidder information and ensure that all mandatory information is completed) OR;
  - d) to sign in if already registered;
  - e) Toggle (click to switch) the "Log an Intent" button to submit a bid;
  - f) Submit bid documents by uploading them into the system against each tender selected.
  - g) Respondents are to submit bid documents by uploading them onto the Transnet system against each tender selected. A Bidder can upload 30mb per upload and multiple uploads are permitted.
  - h) Bidders should ensure that electronic bid submissions are submitted at least a day before the closing date and bidders should not wait for the last hour before the deadline to submit. #### 3 CONDITIONS OF CONTRACT

- 3.1 For this transaction TRIM has identified opportunities of economic transformation and empowerment, TRIM will incorporate a contractual obligation for the winning bidder to execute the identified transformation objective as a condition of contract.
- 3.2 Each bidder interested in participating in this tender should be cognisant that it is a condition of contract the winning bidder will be required to contract with Transnet on one or more of the following transformation initiatives:
  - (a) Job creation and preservation.
  - (b) Enterprise and Supplier Development.

(c) Local Economic Development (Local to site development).

#### 4 RFP INSTRUCTIONS

- 4.1 Please sign documents [sign, stamp and date the bottom of each page] before uploading them on the system. The person or persons signing the submission must be legally authorised by the respondent to do so.
- 4.2 All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.
- 4.3 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers. Any exceptions to this statement must be clearly and specifically indicated.
- 4.4 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 12 below (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

#### 5 JOINT VENTURES OR CONSORTIUMS

Respondents who would wish to respond to this RFP as a Joint Venture [JV] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by Transnet through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

### **SECTION 3: BACKGROUND, OVERVIEW AND SCOPE OF REQUIREMENTS**

#### 1 BACKGROUND

The Kamfersdam submerged line is part of Transnet Rail Infrastructural Manager (TRIM) rail network that is in Hotazel Region, Northern Cape. The line is submerged due to Kamfersdam Dam being flooded because of external discharge, rainfall and surface runoff. The main contributor of high-water levels in the Dam is Sol Plaatje Municipality's constant discharging of sewer water into the Dam. The submerged section is the fastest route connection from Beaconsfield to Fieldsview/Hotazel line compared to Macfarlane line (avoiding line) that is situated in Transcape line.

The railway line is submerged between Roodepan and Homevale. The Macfarlane line is currently used as an alternative to avoid using the submerged line. However, the utilization of this line delays trains with approximately two to three hours on average daily and this results in train cancellations which extremely impact negatively on factors such as client relations, turnaround time, revenue performance and business continuity. This is Manganese export railway line that services Manganese Mines located in Northern Cape Region.

#### 2 EXECUTIVE OVERVIEW

Whereas Transnet is seeking to improve its current process for providing these Goods/Services to its end users community throughout the prescribed locations.

The selected Suppliers/Service provider(s) must share in the mission and business objectives of Transnet. TRIM seeks to appoint a supplier to supply Earth Moving Plant for lifting of Kamfersdam submerged line, between kilometer points: 4/03-2/08 that is in the line between Homevale and Roodepan for a period of 3 months. A successful bidder will be required to meet the following requirements:

- 3.1 The successful contractor is required to supply, operate and maintain the Earth Moving Plan to Kamfersdam for lifting of existing submerged railway line project for the duration of the contract which is three (3) months.

- 3.3 The successful bidder must ensure that his operators and personnel are trained and certified to execute the work.
- 3.4 The successful bidder shall submit proof that the operators are certified competent. The lifting gear must be certified and comply with Transnet Code of Practice No.29.
- 3.5 The successful bidder shall comply with the TRIM's Health and Safety plans.
- 3.6 The successful bidder shall complete, in respect of each day, a daily activity report which reports on staff deployed, the activities which they are carrying out and any unusual occurrences such as interruptions, delays, conflicting instructions, strikes, accidents and the like. The successful contractor shall furnish TRIM with reports, unless otherwise specified, monthly.

#### 4 IMPORTANT CLARIFICATION TO BIDDERS

- 4.1 Establishment and De-Establishment are single line items comprising both activities. If 2 machines are required, 2 Establishment and De-Establishment must be quoted with each being a cost of establishing and de-establishing a machine. Exception is item 4.2. Item 4.2 two roller machines are required, where one will be established as tamping roller and later as smooth roller and other one will be established as one type for the required duration hence the 3 required establishment and de-establishment for 2 machines requested. (Bidders to allow for both types of rollers).
- 4.2 Hours indicated are a combination of all hours required for the number of machines requested. If 4 tipplers are requested and the normal hours quantity is 2376. Each machine will account for 594 hours.
- 4.3 Bidders are to note that machines must come with a full-time mechanic on site.
- 4.4 Bidders are to note that machines must have dip treys.
- 4.5 Bidders are to note that both Safety and Environmental files must be submitted separately either physically or via courier to Kimberly North Depot prior to establishment. This shall be done 7 days prior to work commencement. The award of the order/s between more than one Supplier/Service Provider will not be permissible.
- 4.6 Bidders are to note that all machines must be quoted on **WET RATE.**
- 4.7 Bidders are to note that the contractor must ensure adequate safety of their machine during contract.
- 4.8 Bidders are to note that the required machines will be established between either Roodepan or Homevale. Arrangements will be made with successful bidder.



#### 7.4 STEP Four: Price Negotiations

  - i) the B-BBBEE status level certificate issued by an authorised body or person;
  - ii) a sworn affidavit as prescribed by the B-BBEE Codes of Good Practice; or
  - iii) any other requirement prescribed in terms of the B-BBEE Act.
- (k) "QSE" means a Qualifying Small Enterprise as defines by Codes of Good Practice under section 9 (1) of the Broad-Based Black Economic Empowerment Act, 2003 (Act No. 53 of 2003);
- (I) "rand value" means the total estimated value of a contract in South African currency, calculated at the time of bid invitations, and includes all applicable taxes and excise duties.
- (m) **"Specific goals"** means targeted advancement areas or categories of persons or groups either previously disadvantaged or falling within the scope of the Reconstruction and Development Programme identified by Transnet to be given preference in allocation of procurement contracts in line with section 2(1) of the PPPFA.

#### 3. POINTS AWARDED FOR PRICE

#### 3.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

Where

Ps = Points scored for comparative price of bid under consideration

Pt = Comparative price of bid under consideration

Pmin = Comparative price of lowest acceptable bid
