2 Overview of the work

2.1 Executive Overview

Transnet Port Terminals (TPT) core business is the handling of bulk and break bulk commodities, either entering or exiting via the Richards Bay harbor premises. A network of conveyors, storage areas, transfer houses and galleries form the bulk of the infrastructure for the port operations. In addition, fleet, ship un-loaders, mobile stackers, re-claimers, and ship loaders are some of the larger equipment that is used by the terminal to handle cargo. Cargo received through rail and road transport is staged throughout designated stockpiles. K21 and K24 bins store mineral sands and currently the doors are not in good state for the bins to be used to load cargo. In order for the bins to be used to offload cargo it is vital that we service and repair the bin doors.
