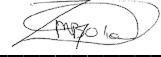

1 Background

Port Elizabeth Multi-Purpose Terminal (PEMPT's) core business is to export dry bulk cargo manganese ore. This is accomplished with terminal infrastructure such as rail wagon tippler, feeders, conveyor belts, storage facilities and ship-loaders and a network of machine mobile equipment such as excavators and bulldozers. The larger network of conveyors is connected via chute and diverter chutes which allow for easy conveying of bulk material to the different conveyor lines. Due to the high number of documentation produced from TPT PEBOT activities, there is less space for storing documents such as drawings. TPT requires a service provider to convert garage number 4 at Workshop 17 to a document office.

2 Objective

This document provides the scope of work for the conversion of a garage to a document office and TPT to approve any new installations during the works.

NB: Site briefing is compulsory.

3 Scope of Work

The service provider will be required to:

- Garage no. 4 space is estimated to be 23 m²,
- Move all components and equipment inside the garage to a new storage area which TPT will show to the service provider,
- Thoroughly clean the garage and remove the steel structure,
- Build a brick wall to separate the office from the other garage and plaster,
- Ensure office is well insulated to prevent any wind, rain, bad weather from entering the document office,
- Paint the new wall white and repaint window and ensure it closes properly,
- Install adequate overhead energy efficient lighting with emergency feature in case of load shedding, test the wall plug and ensure it is functional and secured to the wall,
- Install white ceiling tiles (TPT to approve selection),
- Install office floor grey porcelain ceramic tiles (similar to the one used in TPT offices),
- Remove garage door and replace with brick wall and lockable aluminium double door with a Professional Cylinder Mortise Lock,
- Install wall mounted shelves on the new wall, six (x6) rows through the length of the wall,
- Install A0 document hangers on the opposite wall, two (x2) rows through the length of the wall,
- Move drawing files from Workshop 17 cupboards to document office,
- Move A0 and A4 drawings from Workshop 17 boardroom to document office,
- Move drawings' cabinet from Workshop 17 to document office,
- Replace any items damaged during the works at no cost to TPT,
- Perform quality assurance and control until final inspection and handover,
- Provide a detailed inventory list of all files and documents moved to the document office.

4 Eligibility Criteria

The service provider is required to submit a portfolio showing similar work executed. The scope for each project in the portfolio must be detailed and include pictures and contactable references.

5 General Requirements

- Transnet Port Terminals cannot be held responsible for any injury that occurs on site.
- The work needs to be completed as soon as possible.
- Service provider to supply all materials, tools, labour, etc. unless otherwise specified.
- A safety file needs to be submitted to SHEQ prior to any work.
- Contractor shall practice good “housekeeping” and leave the site clean and tidy.
- Do not use chemicals that will damage the paint work, provide Material Data Sheets.
- Do not cause any spillage on ground, use drip trays where possible.
- When vacating the area the contractor will remove equipment and debris from site. Anything damaged by the contractor will be the responsibility of the contractor to repair that area at their own cost.
- All lifting equipment to have proper certification.
- All workers must be qualified for their specific work- proof of qualification must be included in safety file.
- The contractor must ensure that all its personnel have all the necessary protective clothing whilst within TPT premises.
- All personnel working in the TPT premises must undergo a complete induction course with the SHEQ department before commencing with the project on site.

6 Health and Safety Requirements

- All equipment and installation whether detailed in this document or not, Shall comply with the requirements of the Occupational Health and Safety Act 85 of 1993 as amended by applicable local authorities. All equipment shall be designed to fail to safety.
- At all times during the execution of the task, the service provider will be responsible for the safety of all authorised persons on site and the equipment.

7 Site Information

The location for the works is at Transnet Port Terminals at Workshop 17 in the Port Elizabeth Multipurpose Terminal. Access to the site will be from the existing public and maintenance road networks. Access to the port will be subject to the TNPA and TPT security requirements and regulation.
