- a) The tenderer in respect of the tender described herein above was advertised on 19 February 2024 with a closing time of 16h00 on 14 March 2024. The closing date of the tender was initially extended to 16h00 on 28 March 2024.
- b) On 27 March 2024, the Makanda High Court, Eastern Cape Division, under case number 1100/2024 ordered Transnet SOC Ltd to extend the closing date for the tender until the finalization of Part B (the Review Application). However, it is now clear that the court processes are going to take more time and the closing date must therefore be further extended.
- c) In accordance and in compliance with the terms of this Order of Court, Transnet hereby further extends the closing date from **30 September 2024 at 16h00 to 31 January 2025 at 16h00.**
- d) Kindly take note that the extended closing date of **31 January 2025** is a provisional date which is subject to the outcome of the above-mentioned case. The allocation of the provisional extension date is required for the practical implementation of the court judgment and loading thereof on the Transnet SOC Ltd, e-Tender platform and National Treasury e-Tender Portal.
