1	<p>Please kindly confirm the following:</p> <p><b><u>Under C1.2A SC Contract Data Part 1: Number 3 Time:</u></b></p> <ul style="list-style-type: none"> <li>Point 30.2: What is meant by "The Supplier does not bring the goods to the Delivery Place more than one week before the Delivery Date"?</li> </ul>	<p><b>Tenderers are advised to read through the conditions of contract of the NEC 3 Supply Contract (Red Cover).</b></p> <ul style="list-style-type: none"> <li>Clause 30.2 This means that, the delivery of goods should not be done 7 days prior to the delivery date, so meaning that delivery should be done in days less than 7 before the agreed delivery date.</li> </ul>
2	<p><b><u>Under C1.2A SC Contract Data Part 1: Number 4 Testing and Defects:</u></b></p> <ul style="list-style-type: none"> <li>Point 42: What is meant by the defects date is 104 weeks after Delivery?</li> <li>Points 43.2: What is meant by defects correction period is 2 weeks?</li> <li>Points 42.2 What is meant by the defects period is 3 days?</li> </ul>	<p><b>Tenderers are advised to read through the conditions of contract of the NEC 3 Supply Contract (Red Cover) to understand what a Defect is. In addition, the <i>Purchaser</i> submits the below to assist the tenderer:</b></p> <ul style="list-style-type: none"> <li>Clause 42. Time allocated for the supplier taking full responsibility of any defects on delivered items before TNPA takes full responsibility of the dredger, this will not apply if the defects are the results of negligence by TNPA. All defects notified to the tenderer/successful <i>Supplier</i> must be attended to for the 1<sup>st</sup> 2 years post Delivery of dredger</li> <li>Clause 43.2 Any defect identified by TNPA should be corrected within 2 weeks by the Supplier after access being granted to the dredger.</li> <li>Clause 42.2 Is the time that following notification of the Defect, that TNPA has to arrange access to the defect within 3 days. It refers to within how many days the tenderer/successful <i>Supplier</i> will be granted access to the dredger to assess the defect and ensure the Defect is corrected within the <i>defect correction period</i>.</li> </ul>
