9 EMPLOYMENT EQUITY ACT

10 DISCLAIMERS

Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- a. modify the RFP's Goods and request Respondents to re-bid on any such changes;
- b. reject any Proposal which does not conform to instructions and specifications which are detailed herein;
- c. disqualify Proposals submitted after the stated submission deadline [closing date];
- d. award a contract in connection with this Proposal at any time after the RFP's closing date;
- e. award a contract for only a portion of the proposed Goods which are reflected in the scope of this RFP;
- f. split the award of the contract between more than one Supplier, should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- g. cancel the bid process;
- h. validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;






