Q1	ii) understanding that this is a reissue, so most suppliers have seen the documents for pricing, but still will need more time to validate the prices. Also since this is an open tender inspead of a closed tender, it means transnet requires the best possible offer for the project.			
4-	iii) Siefsa increase in eminent and this needs to be estimated well in order to offer a competitive bid.

Q8	Please confirm if any design has been done for the project. If not, please share the specifications and procedures that the contractor needs to adhere to and also the requirements for end of Job documentation, regarding Drawings, Databooks, P&ID's, Isometrics	
A8	No designs available. Contractor after completion to produce all necessary documentation including designs	
Q9	Will there be any requirement for remote access for the facilities, an industry norm for these facilities now is that there is remote access and also there are cameras for the system.
