3.2 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFQ between the closing date and the date of the award of the business.

3.3 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

5 Employment Equity Act

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

6 Changes to Quotations

Changes by the Respondent to its submission will not be considered after the closing date and time.

7 Binding Offer

Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

8 Disclaimers

8.1 Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that Transnet reserves the right to:

- modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
- reject any Quotation which does not conform to instructions and specifications which are detailed herein;

- disqualify Quotations submitted after the stated submission deadline;
- not necessarily accept the lowest priced Quotation or an alternative bid;
- place an order in connection with this Quotation at any time after the RFQ's closing date;
- award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;
- split the award of the order/s between more than one Supplier/Service Provider should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- cancel the quotation process;
- validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- request audited financial statements or other documentation for the purposes of a due diligence exercise;
- not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provides for it;

10 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

11 Security clearance

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

12 National Treasury's Central Supplier Database

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Transnet is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. Business may not be awarded to a respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD. The CSD can be accessed at <https://secure.csd.gov.za/>.

For this purpose, the attached SBD 1 Form must be completed and submitted as an essential returnable document by the closing date and time of the bid.

13 Tax Compliance

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.

Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

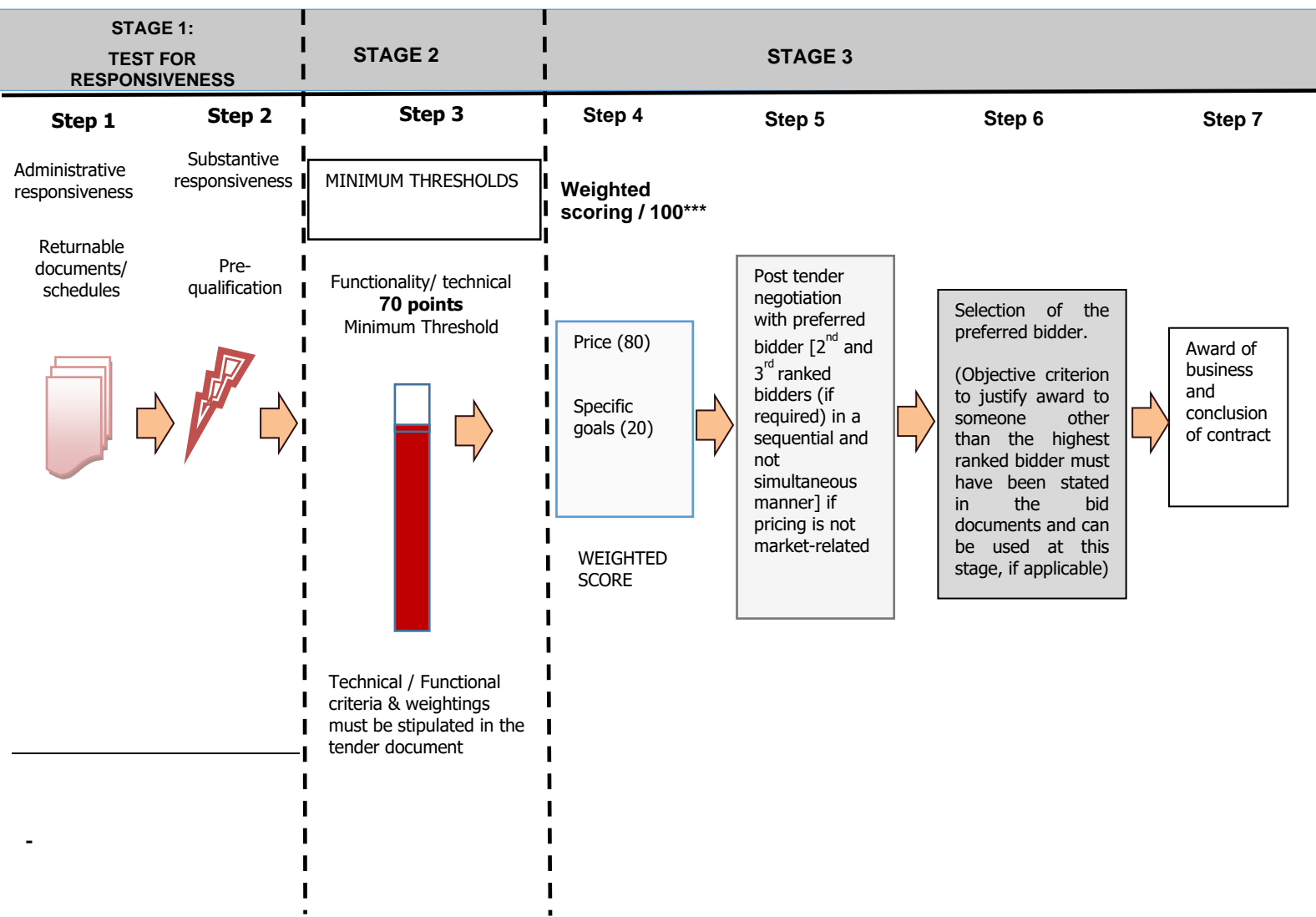

Respondents must complete and submit **Returnable Schedules Section 9,10 and 11**. A Respondent's compliance with the minimum functionality/technical threshold will be measured by their responses to **Returnable Schedules 1,2, 3, and 4**.

Respondents are to note that Transnet will round off final technical scores to the nearest 2 (two) decimal places for the purposes of determining whether the technical threshold has been met.

The minimum threshold for technical/functionality [Step Three] must be met or exceeded for a Respondent's Proposal to progress to Step Four for final evaluation

b) **Specific Goals** [Weighted score 20 point]

- Preference points will be awarded to a bidder for attaining the specific goals requirements in accordance with the table indicated in Section 4.1 of the specific goals Claim Form.

1.5 STEP FIVE: Post Tender Negotiations (Not applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
 - first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
 - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

1.6 STEP SIX: Objective Criteria (Not applicable)

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- Skills Transfer and Capacity Building for Transnet;
- Impact on Transnet's Return On Investment;
- Rotation of Suppliers to promote opportunities for other suppliers, by overlooking a supplier that has been awarded business repeatedly overtime in order to benefit other suppliers in the market;
- the tenderer:
 - is not under restrictions, or has principals who are under restrictions, preventing participating in the employer's procurement,
 - is not undergoing a process of being restricted by Transnet or other state institution that Transnet may be aware of,
 - can, as necessary and in relation to the proposed contract, demonstrate that he or she possesses the professional and technical qualifications, professional and technical competence, financial resources, equipment and other physical facilities, managerial capability, reliability, experience and reputation, expertise and the personnel, to perform the contract,
 - has the legal capacity to enter into the contract
- is not insolvent, in receivership, under Business Rescue as provided for in chapter 6 of the Companies Act, 2008, bankrupt or being wound up, has his affairs administered by a court or a judicial officer, has suspended his business activities, or is subject to legal proceedings in respect of any of the foregoing,
- complies with the legal requirements, if any, stated in the tender data and
- is able, in the option of the employer to perform the contract free of conflicts of interest.
- all Risks identified during a risk assessment exercise/probity check (which may be conducted by an authorised third party) that would be done to assess all risks, including but not limited to:
 - the financial stability of the bidder based on key ratio analysis, which would include, but not be limited to Efficiency, Profitability, Financial Risk, Liquidity, Acid Test, and Solvency;
 - a due diligence to assess functional capability and capacity. This could include a site visit;
 - A commercial relationship with a Domestic Prominent Influential Person (DPIP) or Foreign Prominent Public Official (FPPO) or an entity of which such person or official is the beneficial owner; and
 - Reputational and Brand risks

1.7 STEP SEVEN: Award of business and conclusion of contract

- Immediately after approval to award the contract has been received, the successful or preferred bidder(s) will be informed of the acceptance of his/their Quotation by way of a Letter of Award. Thereafter the final contract will be concluded with the successful Respondent(s).
- Otherwise, a final contract will be concluded and entered into with the successful Bidder at the acceptance of a letter of award by the Respondent.

2 Validity Period

Transnet requires a validity period of **90 [Ninety]** Business Days from the closing date of this RFQ, excluding the first day and including the last day.

Bidders are to note that they may be requested to extend the validity period of their bid, on the same terms and conditions, if the internal evaluation process has not been finalised within the validity period. However,

once the adjudication body has approved the process and award of the business to the successful bidder(s), the validity of the successful bidder(s)' bid will be deemed to remain valid until a final contract has been concluded.

3 Disclosure of contract information

Johannesburg Stock Exchange Debt Listing Requirements

Transnet may also be required to disclose information relating to the subsequent contract i.e. the name of the company, goods/services provided by the company, the value and duration of the contract, etc. in compliance with the Johannesburg Stock Exchange (JSE) Debt Listing Requirements.



1 BACKGROUND

Port Elizabeth Multi-Purpose Terminal (PEMPT's) core business is to export dry bulk cargo manganese ore. This is accomplished with terminal infrastructure such as rail wagon tippler, feeders, conveyor belts, storage facilities and ship-loaders and a network of machine mobile equipment such as excavators and bulldozers. The larger network of conveyors is connected via chute and diverter chutes which allow for easy conveying of bulk material to the different conveyor lines. To ensure health and safety of TPT mobile heavy equipment operators and to extend the life of this equipment, the Technical Department aims to repair two (2) excavator machines as detailed in this Scope of Work.

2 OBJECTIVE

The purpose of this Scope of Work is for the service and repair of two (2) Volvo Excavator machines for PE terminal taking the following requirements into account:

- Two (2) new excavator cabins and repairs of the chassis'.
- An electronic, mechanical, and hydraulic service and repair of the entire machine.
- Ensure that from a structural perspective the machines are as good as new.
- Ensure that the machines are mechanically sound and will run without issue until the next major service.

3 SCOPE OF WORK

3.1 This scope is for the repairs of two (2) excavator machines and shall include:

3.1.1 supply and installation of two (2) new excavator cabins,

3.1.2 repair of the chassis',

3.1.3 engine service, and

3.1.4 hydraulic system service.

3.2 New components fitted must be completely compatible and interchangeable with the currently installed on the Volvo Construction Equipment excavator machines.

3.3 The excavator cabins replacement must meet Original Equipment Manufacturer standards. The specification of the excavator machines is:

- Manufacturer: Volvo Construction Equipment
- Model/Type: EC210B LC

3.4 Currently installed are operator cabins on the machines with the following specification:

- Manufacturer: Volvo Construction Equipment
- Part No.: 14538703

3.5 The new cabins must be fully equipped and include all the internal components and accessories such as:

- Cabin glass, windows, and seals.
- Switches e.g. Engine speed control switch, etc.
- Wipers.
- Door locks and keys.
- Handholds and handrails.
- Electronics such as front instrument panel and radio.
- Power socket.
- Heating, ventilation, and air-conditioning.
- Internal lights.
- External lights and beacon.
- Operator seat (must meet EN ISO 7096), control switches, seat belt.
- Operating levers and pedals.
- Fire extinguisher.

- Emergency exit hammer.
 - Mirrors.
 - Battery compartment covers and engine compartment covers, hydraulic compartment covers.
- 3.6 The excavator cabins to be installed must have a Roll-Over Protective Structure (ROPS) in accordance with International Standards Organization (ISO) 12117-2 – Earth-moving machinery – Laboratory tests and performance requirements for protective structures of excavators – Part 2: Roll-over protective structures (ROPS) for excavators of over 6 t.
- 3.7 The repairs for the chassis or undercarriage shall include but is not limited to:
- 3.7.1 Clean chassis or undercarriage.
 - 3.7.2 Treat any corrosion detected and apply corrosion protection.
 - 3.7.3 Reinstall cabins on machines.
 - 3.7.4 Get a Volvo Construction Equipment dealer undercarriage inspection for both excavators and provide report to TPT.
- 3.8 Service air conditioning system:
- 3.8.1 Replace air conditioner/heater filter (ambient and main).
 - 3.8.2 Replace air conditioner belt.
 - 3.8.3 Service heating and cooling units.
- 3.9 Repair buckets to as good as new condition.
- 3.10 The service provider must repair, sandblast and paint (TPT specification: Corrosion protection EEAM-Q-008 – Annexure A) the chassis of the excavators before installation of the new cabins. The new cabins shall be painted in Transnet Red (RAL 3020) with Transnet logos on sides in white lettering as per Annexure A. The boom and bucket shall also be painted.
- 3.11 The engine service scope shall cover:
- 3.11.1 Replacement of engine oil.

- 3.11.2 Replacement of coolant.
- 3.11.3 Replacement of all filters i.e. oil filter, air ventilation filter on fuel tank, fuel filter, air filter (primary and secondary).
- 3.11.4 Replacement of fan belt.
- 3.11.5 Replacement of hoses: fuel hose, heater hose, and turbocharger lubricating oil hose.
- 3.11.6 Valve clearance check/adjustment.
- 3.11.7 Replacement of water separator element.
- 3.11.8 Replacement of turbo, pipes, exhaust manifold, muffler, and exhaust.
- 3.11.9 Replacement of air intake and pipes up until the turbo.
- 3.11.10 Replacement radiator, oil cooler, charge air cooler, and condenser.
- 3.11.11 Replace water pump.
- 3.12 The hydraulic service scope shall cover:
 - 3.12.1 Overhaul of hydraulic cylinders i.e. all boom cylinders, arm cylinder, bucket cylinder, and track slack adjusting cylinders.
 - 3.12.2 Replacement of filters i.e. return, drain, servo.
 - 3.12.3 Replacement of element in the pilot filter.
 - 3.12.4 Replacement of element in the air breather on the hydraulic tank.
 - 3.12.5 Replacement of oils for swing drive case and track drive case.
 - 3.12.6 Clean suction strainer.
 - 3.12.7 Replacement of hoses: pump inlet and outlet hose, swing line hose, boom cylinder hose, arm cylinder line hose, and bucket cylinder line hose.
 - 3.12.8 Adjust track slack for rocky ground.
 - 3.12.9 Service hydraulic pumps: main pump and pilot pump.
 - 3.12.10 Service travel and swing hydraulic motors.

- 3.13 Clean the entire machine and grease the swing ring gear bearing, bucket and boom mounting pins, and all hydraulic cylinder pins.
- 3.14 Clean and unblock grease system pipes.
- 3.15 Refer to Annexure J for equipment and part identification numbers.
- 3.16 All work will be done at the service provider's workshop.
- 3.17 Commissioning of the machines shall constitute 40 operational hours upon arrival to TPT premises. If equipment fails the 40-hour test due to a component(s) repaired, the service provider shall rectify the fault and commissioning shall continue.

4 QUALITY

- 4.1 The excavators will be accepted when the machines have been successfully commissioned and tested and all manuals, and drawings required for the newly installed components have been delivered to TPT.
- 4.2 The service provider is required to submit a detailed bar chart showing all major activities and identifying all major milestones to be achieved in this project.
- 4.3 The service provider is required to have a site manager who has been delegated sufficient authority to manage the site activities up until commissioning and acceptance of the machines.
- 4.4 The service provider shall be required to install and operate a quality management system which conforms to ISO 9001.
- 4.5 Each bidder must submit a detailed statement of his/her quality system which shall include the following:
 - 4.5.1 Statement of quality management policy and objectives.
 - 4.5.2 Statement of customer requirements evaluation.
 - 4.5.3 Statement of documentation and change control procedure.

Lead time confirmation and project plan overview must be attached to Returnable Schedule T7.




