2. BACKGROUND

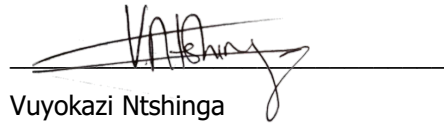

However, in Mafikeng (cluster 1) which was the first site for the compulsory briefing session, the session was disrupted by the residents who introduced themselves to TE representatives as businesspeople of Mafikeng who then demanded that the tender must be published only for Mafikeng residents not in the National Treasury website. SAPS representative who arrived in Transnet premises (Mafikeng) advised that the briefing session must be cancelled as they will not be able to remove the instigators in Transnet premises.

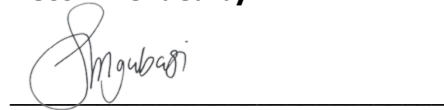
