# 1 Responses to RFQ

- 1.2 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFQ between the closing date and the date of the award of the business.
- 1.3 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

#### 2 Legal Compliance

The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

#### 3 Employment Equity Act

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

#### 4 Changes to Quotations

Changes by the Respondent to its submission will not be considered after the closing date and time.

#### 5 Binding Offer

Any Quotation furnished pursuant to this Request shall be deemed to be an offer. Any exceptions to this statement must be clearly and specifically indicated.

#### 6 Disclaimers

- Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that Transnet reserves the right to:
  - modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
  - reject any Quotation which does not conform to instructions and specifications which are detailed herein:
  - disqualify Quotations submitted after the stated submission deadline;
  - not necessarily accept the lowest priced Quotation or an alternative bid;
  - place an order in connection with this Quotation at any time after the RFQ's closing date;
  - award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;

- split the award of the order/s between more than one Supplier/Service Provider should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
- cancel the quotation process;
- validate any information submitted by Respondents in response to this bid. This would include, but is
  not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid,
  Respondents hereby irrevocably grant the necessary consent to Transnet to do so;
- request audited financial statements or other documentation for the purposes of a due diligence exercise;
- not accept any changes or purported changes by the Respondent to the bid rates after the closing date and/or after the award of the business, unless the contract specifically provides for it;
- to cancel the contract and/request that National Treasury place the Respondent on its Database of Restricted Suppliers for a period not exceeding 10 years, on the basis that a contract was awarded on the strength of incorrect information furnished by the Respondent or on any other basis recognised in law;

Bidders may therefore be requested to advise whether they would still be prepared to provide the required Goods/Services at their quoted price.
- Should a bidder fail to respond to a request for extension of the validity period before it expires, that bidder will be excluded from tender process.

## 7 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

#### 8 Security clearance

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

# 9 National Treasury's Central Supplier Database

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Transnet is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. Business may not be awarded to a respondent who has failed to register on the CSD. Only foreign suppliers with no local registered entity need not register on the CSD. The CSD can be accessed at https://secure.csd.gov.za/.

For this purpose, the attached SBD 1 Form must be completed and submitted as a mandatory returnable document by the closing date and time of the bid.

#### 10 Tax Compliance

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.

The Tax Compliance status requirements are also applicable to foreign Respondents/ individuals who wish to submit bids.



Respondents must complete and submit <u>Annexure</u> B which include a Technical Questionnaire. A Respondent's compliance with the minimum functionality/technical threshold will be measured by their responses to Annexure B Respondents are to note that Transnet will round off final technical scores to the nearest 2 (two) decimal places for the purposes of determining whether the technical threshold has been met.

#### 1.8 STEP FIVE: Post Tender Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
  - o first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
  - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

#### 1.9 STEP SIX: Objective Criteria

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- Skills Transfer and Capacity Building for Transnet;

- Impact on Transnet's Return On Investment;
- Rotation of Suppliers to promote opportunities for other suppliers, by overlooking a supplier that has been awarded business repeatedly overtime in order to benefit other suppliers in the market;
- the tenderer:

# **SECTION 1**

# 1 Description of the works

#### 1.1 Executive overview

Transnet port terminals, Port of Richards Bay Facilities department, requires a service provider to hire the company with one cherry picker (mobile articulated boom lift) with operator for the time frame of 30 days. The maximum working height is 28 meters. Currently several buildings in port of Richards Bay are multi-story and have high, inaccessible roofs. Cherry picker equipment is required to provide access to repairs of cladding.

## 1.2 Employer's objectives

Employers' objective is to appoint a successful bidder to hire Transnet port Terminals Richards Bay with a cherry picker.

# 1.3 Specific requirements for cherry picker

- 1.3.1. The Employer to hire Cherry picker with an Operator from the service provide.
- 1.3.2. The machine must bill the employer on the hourly rating and rate must include the operator and machine.
- 1.3.3. The cherry picker equipment will be required for approximately of 8 hours a day, if the planed project will take long the machine Operator will be notified.
- 1.3.4. All instructions to the service provider shall be confirmed in writing and only requests that are received in writing or via email
- 1.3.5. The latest test certificate for the cherry picker should be provided
- 1.3.6. The service provider shall supply a delivery note upon completion of works executed on site.
- 1.3.7. Cherry picker supplier to be regarded as a lifting machinery entity (LME) to be registered with the labour department.
- 1.3.8. Key personnel required shall comply with the relevant experience and certification requirements
- 1.3.9. Key personnel cherry picker shall include the following
- 1.3.10. Cherry picker operators: operators to hold valid certificates of competence complying to the OHS Act 1993, department of labour's driven machinery regulations. Valid certificate of competence, issued by a training provider accredited by Transnet port terminals



1.3.11. Lifting machinery inspector (LMI) -LMI to hold valid certificates of competence complying with the OHS Act 1993, department of employment and labour's driven machinery regulations 2015 and all other applicable Act

# 1.4 Scope of work requirements

1.4.1. Transnet port of Richards Bay requires a service provider to supply one cherry picker (mobile articulated lift) with operator for the period of 30 days

# 1.5 Work Descriptions that require cherry picker

- 1.5.1. Repairs of leaking pipes and damaged pipes at Delko plant
- 1.5.2. Unblocking and repairs of all drainage pipes from the galleries
- 1.5.3. Repairs of damage Building roofs
- 1.5.4. Service of ship loader, unloaders and in event of any Loader failure that requires cherry picker access
- 1.5.5. Remove and repair of broken cladding at the transfer points of the conveyor belt

## 1.6 The Cherry picker requirements is as follows

- 1.6.1. The cherry picker must be capable of reaching minimum height of 28 meters.
- 1.6.2. A provision usage plan will be provided to the service provider. In the event of the plan changes the service provider will be notified the day before, where the cherry picker will be used.
- 1.6.3. The driver will need to keep record log (a daily log) on where the cherry picker was used, who use it and the duration of use.
- 1.6.4. The service provider shall transport the equipment by means of relevant transportation to the TPT premises and commission the equipment as per TPT instruction. Upon completion of the utilization, the service provider shall remove the equipment off TPT premises by similar means of transportation.

- 1.8.3. Ensure the compliance with local safety standards and regulations.
- 1.8.4. The latest cherry picker certificate must be provided.

### 1.9 Quality assurance requirements

- 1.9.1. All services supplied and delivered to Transnet must be of excellent quality in compliance with the specifications. Should the goods and services not be in conformity with the specifications, Transnet reserves the right reject them, obtain the good or services from the other sources of its free choice and debit the difference in cost if any to the service provider.
- 1.9.2. The service provider must have permanently manned telephone number (place of business or cell phone) to ensure immediate contact can be made in the case of emergency.
- 1.9.3. Service provider to provide TPT with quality control plan for the task, which shall be reviewed and approved by TPT.
