10 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

11 Security clearance

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

12 National Treasury's Central Supplier Database

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Transnet is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. 13 Tax Compliance

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).



1.5 STEP FIVE: Post Tender Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
 - o first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
 - negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

1.6 STEP SIX: Objective Criteria (if applicable)

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- Skills Transfer and Capacity Building for Transnet;
- Impact on Transnet's Return On Investment;
- Rotation of Suppliers to promote opportunities for other suppliers, by overlooking a supplier that has been awarded business repeatedly overtime in order to benefit other suppliers in the market;
- the tenderer:
- is not under restrictions, or has principals who are under restrictions, preventing participating in the employer's procurement,

- is not undergoing a process of being restricted by Transnet or other state institution that Transnet may be aware of,
- can, as necessary and in relation to the proposed contract, demonstrate that he or she possesses the
 professional and technical qualifications, professional and technical competence, financial resources,
 equipment and other physical facilities, managerial capability, reliability, experience and reputation,
 expertise and the personnel, to perform the contract,
- has the legal capacity to enter into the contract

2 Overview of the work

2.1 Executive Overview

Transnet Port Terminals is a division of Transnet SOC Limited whose core business is to provide cargo handling to a wide spectrum of customers, including shipping lines, freight forwarders and cargo owners. 3 Detailed Scope of Work

3.1 Detailed Scope of Work

- 3.1.1 The fire fighters will be stationed at various key points along the conveyor belts.
- 3.1.2 Fire fighters will monitor conveyor belts and surrounding areas during and after any operational activities that present fire risk.
- 3.1.3 Fire fighters will be deployed on a 24-hour basis, following the terminal's operational schedules to provide uninterrupted coverage.
- 3.1.4 The team must be capable of responding to fire alarms and emergencies within a specified time frame of 5-10 min from alert.
- 3.1.5 Fire fighters must undergo periodic training and participate in safety drills to stay prapred for different scenarios such as industrial fires, chemical spills or structural fires.
- 3.1.5 Fire fighters will have to identify fire hazards such as the accumulation of flammable materials, overheating of equipment, or malfunctioning systems along the conveyor belts.
- 3.1.6 In the event of a fire, fire fighters must initiate emergency procedures, control the fire, protect lives and property. Maintain continuous communication with operational teams to ensure that any potential risks are identified early.
- 3.1.7 Ensure compliance with all safety standards, including wearing appropriate PPE and following company safety protocols during fire watch duties.
- 3.1.8 After completion of any operation, especially high-risk operation, the fire fighters must continue monitoring for at least 30 minutes to ensure no residual fire risk remain.

5 General Contract Activities

5.1 Watching of Conveyor Belts

Service provider shall be required to watch for any possible fire sparks on conveyor belts infrastructure of the designated areas namely:

- a) Woodchips route.
- b) Coal route
- c) Sulphur routes
- d) General routes

5.1.1 Bidders must note that the above requirement is indicative and may change at a point of intent, whereby as and when resource allocation may be concentrated where high demand of service is identified by Transnet.

- 5.1.2 Health and Safety is a critical elementary factor required on a mandatory bases when fire watching the conveyor belts because for the safety hazards associated with these systems.

9 Site Information

9.1 Site conditions

The works are undertaken next to a highly dusty area and care should be taken to safeguard against this. Surgical masks and safety goggles must always be used when working or walking in the plant.

The groundwater table has been recorded at between 0.8 m and 1.5 m below ground level across the site during winter. The equipment to be rigged is to be for 24 hours per day operation in an environment subject to the following conditions:

- Altitude sea level
- Ambient temperature 5 to 45 °C
- Relative humidity frequently 100%
