#### Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

### • Security clearance

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of CONFIDENTIAL/ SECRET/TOP SECRET. - Transnet may, in writing, request the Operator to confirm and/or make available any personal information and the information of a third party in its possession in relation to Transnet and if such personal information has been accessed by third parties and the identity thereof in terms of the POPIA.
- Transnet may further request that the Operator correct, delete, destroy, withdraw consent or object to the
  processing of any personal information and the information of a third party relating to the Transnet or a third party
  in the Operator's s possession in terms of the provision of the POPIA and utilizing Form 2 of the POPIA Regulations.
