



EVALUATION METHODOLOGY





Evaluation Methodology

Step One: Administrative responsiveness

- Whether the bid has been lodged on time.
- Whether all Returnable Documents and/or schedules were completed and returned by the closing date and time.
- Verify the validity of all Returnable Documents.

Step Two: Substantive responsiveness

- Whether any general pre-qualification criteria set by Transnet, have been met. i.e.,
 Compliance to the eligibility criteria
- Proof of attendance of compulsory briefing session.
- Land Rights and Capacity
- Whether the proposal materially complies with the scope and/or specification given



Step 3 - Technical Evaluation

Minimum Threshold of 70% for Technical Criteria and Functional Requirements. Technical shall be scored in accordance with the following returnables:

RETURNABLE SCHEDULE 1: LAND RIGHTS AND CAPACITY

RETURNABLE SCHEDULE 2: EXPERIENCE

RETURNABLE SCHEDULE 3: REPORT OF THE PROPOSED

SOLUTION AND/OR EXPRESSION OF INTEREST

The evaluation criteria is discussed in detail in the Technical presentation.






EVALUATION METHODOLOGY
