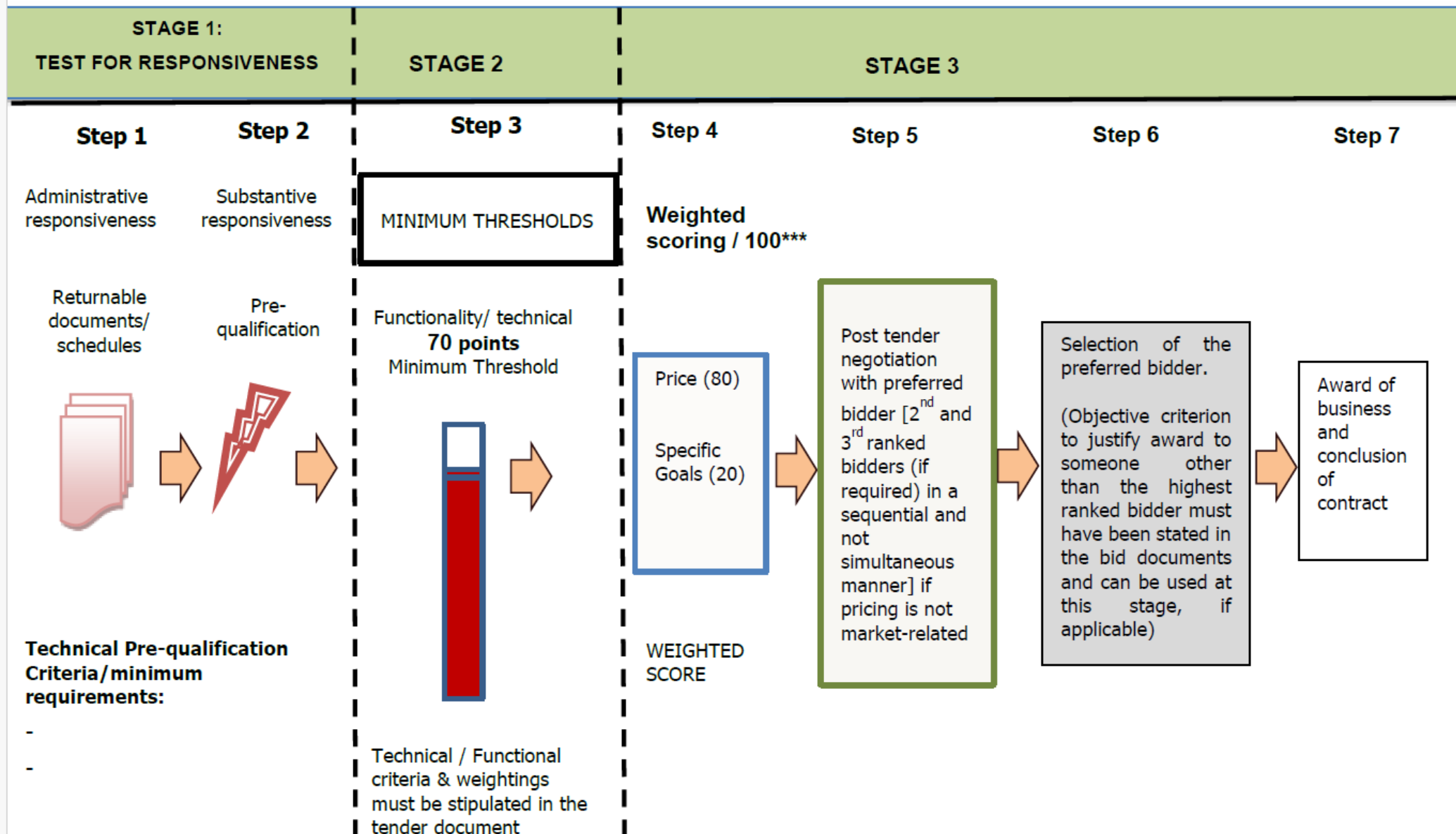

# Questions and answers

- Is it only online submissions allowed for this tender?
  - Transnet no longer accepts physical submission or email submission, Yes only online submissions allowed as indicated on the RFP, steps to submit are on the RFP document.
- Are the Letter of awards accepted or purchase orders regarding reference letters?
  - No letter of awards and purchase orders will be accepted, only refence letter with contactable details and must be on the letterhead of the company that is doing the referral.
- Are the bidders allowed to bid for only one cluster or they must bid for all the clusters?
  - Bidders are allowed to bid for one cluster or more clusters
- Are bidders allowed to do walkabout inside the depots without PPE
  - Bidders are not allowed, it is indicated on the RFP documents that the bidder must have their PPE for the site briefing meetings in all the areas.



# Questions and answers

- When will the tender be awarded?
  - The Tender will be awarded after the evaluation process has taken place and all Transnet Engineering supply chain management process is done.
- Are the bidders that did not attend other site briefing areas allowed to bid?
  - It was clarified that this is not the meeting to disqualify any bidder or any bid, but the meeting is for a bid clarification and site viewing. However bidders must refer to the RFP document on page 7 on clause 1.2 and 1.3.
- Bidders enquired about Section 4 of the pricing schedule
  - It was clarified to the bidders that Section 4 must be a total of all the costs on Annexure G and F then incorporate totals with Annexure E (Pricing Schedule) that will be quoted for each year and must provide escalations for Year 2 and Year 3 based on the applicable indices. It was also noted to the bidders that the price quoted for the period of 36 months will be fixed and firm for the duration of the contract period (36 months).

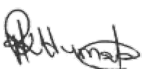
