1. SCOPE OF WORK:

1.1 This document covers the requirements to repair hinge points for STS Crane (QC01).

1.2 The scope of work shall include the following but is not limited to:

1.2.1 Execute the works as detailed under section 2 of this document.

2. DETAILED REQUIREMENTS:

- 2.1 Remove both old existing hinge points
- 2.2 Install new hinge points with original thickness.
- 2.3 Replace and repair all defective parts.
- 2.4 Paint all components with Jotun Paint (OEM Colour)
- 2.5 Replace all bolts with stainless steel bolts.
- 2.6 Hinge points must be as per OEM spec and standard.
- 2.7 Return old, damaged hinge points to Pier1 workshop.
- 2.8 Commission with TPT representative as a witness.

3. OTHER REQUIREMENTS:

- 3.1 Only contractors that can demonstrate sufficient recent experience in repairing hinge points for STS cranes shall be considered.
 - 3.1.1 The contractor must provide sufficient information and references with their response to enable Transnet Port Terminals to determine their level of experience as indicated in Annexure A.
 - 3.1.2 Reference lists shall include addresses as well as contact persons who may be visited for inspection of the equipment during the adjudication period.
 - 3.1.3 Transnet Port Terminals will not consider any contractors offer that, in the sole opinion of Transnet Port Terminals, does not have adequate experience and/or adequate equipment to ensure quality in their work.
 - 3.1.4 State the lead time from award of purchase order to work completion.
