The successful Respondent shall be in full and complete compliance with any and all applicable national and local laws and regulations.

#### 5 Employment Equity Act

Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

#### 6 Changes to Quotations

Changes by the Respondent to its submission will not be considered after the closing date and time.

#### 8 Disclaimers

- Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFQ and/or its receipt of a Quotation in response to it. Please note that Transnet reserves the right to:
  - modify the RFQ's goods / service(s) and request Respondents to re-bid on any changes;
  - reject any Quotation which does not conform to instructions and specifications which are detailed herein;
  - disqualify Quotations submitted after the stated submission deadline;
  - not necessarily accept the lowest priced Quotation or an alternative bid;
  - place an order in connection with this Quotation at any time after the RFQ's closing date;
  - award only a portion of the proposed goods / services which are reflected in the scope of this RFQ;
  - split the award of the order/s between more than one Supplier/Service Provider should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations;
  - cancel the quotation process;

#### 10 Legal review

A Proposal submitted by a Respondent will be subjected to review and acceptance or rejection of its proposed contractual terms and conditions by Transnet's Legal Counsel, prior to consideration for an award of business.

#### 11 Security clearance

Acceptance of this bid could be subject to the condition that the Successful Respondent, its personnel providing the goods and its subcontractor(s) must obtain security clearance from the appropriate authorities to the level of

CONFIDENTIAL/ SECRET/TOP SECRET. Obtaining the required clearance is the responsibility of the Successful Respondent. Acceptance of the bid is also subject to the condition that the Successful Respondent will implement all such security measures as the safe performance of the contract may require.

#### 12 National Treasury's Central Supplier Database

Respondents are required to self-register on National Treasury's Central Supplier Database (CSD) which has been established to centrally administer supplier information for all organs of state and facilitate the verification of certain key supplier information. Transnet is required to ensure that price quotations are invited and accepted from prospective bidders listed on the CSD. #### 13 Tax Compliance

Respondents must be compliant when submitting a proposal to Transnet and remain compliant for the entire contract term with all applicable tax legislation, including but not limited to the Income Tax Act, 1962 (Act No. 58 of 1962) and Value Added Tax Act, 1991 (Act No. 89 of 1991).

It is a condition of this bid that the tax matters of the successful Respondents be in order, or that satisfactory arrangements have been made with South African Revenue Service (SARS) to meet the Respondents tax obligations.



#### 1.5 STEP FIVE: Post Tender Negotiations (if applicable)

- Respondents are to note that Transnet may not award a contract if the price offered is not market-related. In this regard, Transnet reserves the right to engage in PTN with the view to achieving a market-related price or to cancel the tender. Negotiations will be done in a sequential manner i.e.:
  - o first negotiate with the highest ranked bidder or cancel the bid, should such negotiations fail,
  - o negotiate with the 2nd and 3rd ranked bidders (if required) in a sequential manner.
- In the event of any Respondent being notified of such short-listed/preferred bidder status, his/her bid, as well as any subsequent negotiated best and final offers (BAFO), will automatically be deemed to remain valid during the negotiation period and until the ultimate award of business.
- Should Transnet conduct post tender negotiations, Respondents will be requested to provide their best and final offers to Transnet based on such negotiations. Where a market related price has been achieved through negotiation, the contract will be awarded to the successful Respondent(s).

#### 1.6 STEP SIX: Objective Criteria (if applicable)

Transnet reserves the right to award the business to the highest scoring bidder/s unless objective criteria justify the award to another bidder. The objective criteria Transnet may apply in this bid process include:

- Skills Transfer and Capacity Building for Transnet;
- Impact on Transnet's Return On Investment;
- Rotation of Suppliers to promote opportunities for other suppliers, by overlooking a supplier that has been awarded business repeatedly overtime in order to benefit other suppliers in the market;
- the tenderer:
- is not under restrictions, or has principals who are under restrictions, preventing participating in the employer's procurement,

- A person will not be awarded points for B-BBEE status level if it is indicated in the bid documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an EME that has the capability and ability to execute the sub-contract.
- A person awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an EME that has the capability and ability to execute the sub-contract.
- 4.7 Bidders are to note that the rules pertaining to B-BBEE verification and other B-BBEE requirements may be changed from time to time by regulatory bodies such as National Treasury or the DTI. It is the Bidder's responsibility to ensure that his/her bid complies fully with all B-BBEE requirements at the time of the submission of the bid.

- 2.2 Remove and lower mast with 30-ton crane.
- 2.3 Old mast to be cut and disposed on dedicated metal skip.
- 2.4 New pole to be supplied by Transnet Port Terminals.
- 2.5 Mast to be supported on suitable trestle not obstructing the operation (service provider shall supply its own trestles).
- 2.6 Remove headgear and ring.
- 2.7 Remove all internal cables.
- 2.8 Renew 5-core trailing cable with male connector at either end.
- 2.9 Check all pulleys/rollers in good order, grease all lubrication points / changes bushes on pulleys.
- 2.10 Replace all worn damaged parts.
- 2.11 Paint top cover and ensure integrity of lightning arrestor.
- 2.12 De-rust and clean pole with sigma GP liquid cleaner and prime pole with sigma cover 280 yellow /green primer one coat then paint pole with Sigmadur 550.
- 2.13 Sigmadur 550 to be enhanced with luminous paint properties (glow in the dark).
- 2.14 Finishing coat -gel coat that complies to sans 1749, uniform thickness between 250 & 500 microns, weatherproof, uv resistant, flame-resistant & impact-strong surface.
- 2.15 Treat with approved undercoating.
- 2.16 Paint grey and yellow as per surrounding poles (Golden yellow and French grey as well as the light bracket and cover two coats of paint).
- 2.17 Paint black stencilled number on pole door.
- 2.18 Re-wire ring (2.5 mm silicon wire), install new splitter/weatherproof box with female connector mounted on for supply.
- 2.19 Reinstall ring
- 2.20 Remove all the existing lights and gear (1000w lamps, ballasts, capacitors etc.), and replace with new 10 x LED 400w lights.

- 2.21 Scrap of removed materials to disposed at Transnet Port Terminals.
- 2.22 Ensure luminar glasses are clean and sealed.
- 2.23 Copper-slip all bolts & screws on ring & headgear (replace any rusted).
- 2.24 Reinstall headgear.
- 2.25 Renew cables 8mm s/steel flex stranded grade 316 Thimble end to use copper ferrules to ensure steel cables do not overlap or cross within pole.
- 2.26 Torque luminar ring in docked position at 20NM.
- 2.27 Mast to be reinstall into position.
- 2.28 Male plug must fit into female plug on junction box without obstructions.
- 2.29 Canopy must be diagonal with pole door.
- 2.30 After pole is erected, headgear and ring must be lowered and redocked to test the operation on the pole by means of high mast pole gear. This exercise must be done in a presence of Technical Supervisor/Manager of Transnet Port Terminals.
- 2.31 Base bolts to be torqued and copper slip applied (all bolts to be examined and if necessary, replaced).
- 2.32 Dock mast correctly and be torqued.
- 2.33 Replace distribution board complete, to match surrounding pole distribution boards.
- 2.34 Re-instate earthing of pole (incomer to pole and to pole distribution board).
- 2.35 Reconnect & test mast for satisfactory working.
- 2.36 30-ton mobile crane required for process.
